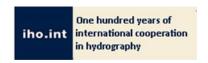

Dear Hydrographer,

- 1. The 13th meeting of the Hydrographic Services and Standards Committee (HSSC-13) was initially planned from 24 to 28 May in Den Pasar, Bali, Indonesia, hosted by the Hydrography and Oceanography Centre of the Indonesian Navy (Pushidrosal). After careful consideration and in liaison with the host country as indicated in Reference E, the option to conduct a face-to-face meeting in 2021 does not seem realistic while the intention to keep the phasing with the Council meeting countdown and the working groups meetings remains important.
- 2. As a consequence, it has been decided that HSSC-13 will be held as a video teleconference (VTC) meeting only, using the gotomeeting platform operated by the IHO Secretariat. HSSC-13 will be held from 3 to 7 May, as follows:

4. All delegates intending to participate in HSSC-13 are invited to register through the IHO online registration system (HSSC-13) **no later than 30 April 2021.** In addition, Stakeholders willing to make a presentation are requested to inform the HSSC Secretariat by email to dtech@iho.int, with the title/abstract of their presentation as soon as possible and **no later than 31 March 2021**.

Draft Agenda and Timetable for HSSC-13

5. A draft agenda and timetable for HSSC-13 is provided in **Annex A** which takes into account some topics and issues raised at the 2nd Session of the Assembly and at the 4th meeting of the Council (References A, B and C) as well as the most important actions and decisions from HSSC-12 (Reference D). Member States and Observers are requested to review the draft agenda and programme and provide any comments or proposals for new or amended subjects to the HSSC Secretariat **by 31 March 2020**. If necessary, a revised draft agenda and timetable will be prepared and posted on the IHO website > ... > HSSC-13.

Deadlines for HSSC-13

6. Documents intended for consideration at HSSC-13 should be submitted to the HSSC Secretariat in accordance with the "Instructions for the Submission of Reports and Proposals for Consideration by HSSC". With the exception for substantive submissions, it is agreed that the Chairs of the working groups (WGs) and Stakeholders may provide summary reports only, using the HSSC PowerPoint® template and additional comprehensive documents if appropriate (proposals to be endorsed for instance).

7. HSSC-13 will give consideration to the preparation of the 5th meeting of the IHO Council (C-5) with a view to support the preparation of the IHO Work Programme for 2022 and the maintenance of version 1.0 of the Roadmap for the S-100 Implementation Decade (2020 – 2030)¹. The consolidated HSSC Work Plan for 2020-22 (dated 14 November 2020) is available on the HSSC webpage > Miscellaneous and must be used by the WGs as the reference from which amendments to work items can be submitted for endorsement or approval by HSSC. It is also planned to consider the possible inputs to the programme of work of the joint IHO-Singapore Innovation and Technology Laboratory (Decision A2/08 and C4/ 06 refer) and the relationship with HSSC. Finally, HSSC will prepare recommendations to the Council on the

implementation of some ISO 9001 Principles (Action C4/40 refers) planned to be applied to the development of the S-101 Product Specification and will prepare a report on the implementation of the new Strategic Performance Indicators allocated to HSSC (Decision/action C4/39 refers).

- 8. Some other decisions and actions from A-2, C-4 and HSSC-12 need a specific focus. This is reflected in the proposed agenda in Annex A as appropriate. This is in particular the case for the establishment of a new S-130 Project Team under HSSC (S-130 *Polygonal demarcations of global sea areas*) and for Action HSSC12/18 (Dual-Fuel Concept Principles) for which a summary report on the various options offered to Hydrographic Offices for preparatory steps be taken towards production of S-101 ENCs (in conjunction with S-57 maintenance/production) is expected.
- 9. All documents will be posted on the IHO website > ... > HSSC-13 webpage as and when they are received. Delegates are requested to circulate these documents amongst their relevant subject matter experts and consolidate any appropriate comments to allow effective decision making at the meeting of the HSSC and avoid, as far as possible, the need to defer decisions to allow further post-meeting technical consultations.

Miscellaneous

- 10. The current list of HSSC contacts is kept updated on the IHO HSSC webpage (<u>Link</u>). Any changes should be forwarded to the HSSC Secretariat (<u>yves.guillam@iho.int</u>) at the earliest opportunity.
- 11. According to the discussions the IHO Secretariat had with Pushidrosal so far, investigations are currently in progress to plan HSSC-14 in Indonesia in May 2022 with a back-up plan in Finland as initially planned last year. Proposals for hosting HSSC-15/-16 in May 2023/24 are welcome at any time and preferably **prior to HSSC-13**.
