

- 1. Reference A proposed the adoption of Edition 4.3.0 of IHO Publication S-57 Appendix B.1, Annex A *Use of the Object Catalogue for ENC* and Edition 7.0.0 of IHO Publication S-58 *ENC Validation Checks* as recommended by the IHO ENC Working Group (ENCWG); and Edition 2.0.0 of IHO Publication S-99 *Operational Procedures for the Organization and Management of the IHO Geospatial Information Registry* recommended by the IHO S-100 Working Group (S-100WG). These Publications have all been endorsed by the IHO Hydrographic Services and Standards Committee (HSSC) (see Reference B).
- 2. The Secretariat of the IHO thanks the 42 Member States that replied to Reference A: Algeria, Australia, Bangladesh, Belgium, Brazil, Canada, Chile, Colombia, Croatia, Cuba, Cyprus, Denmark, Estonia, Finland, France, Germany, Greece, Indonesia, Iran (Islamic Republic of), Ireland, Italy, Japan, Latvia, Malaysia, Mexico, Morocco, Netherlands, New Zealand, Norway, Peru, Philippines, Poland, Republic of Korea, Romania, Singapore, Slovenia, South Africa, Spain, Sweden, Tunisia, United Kingdom of Great Britain and Northern Ireland and the United States of America.
- 3. All forty two Member States supported the adoption Edition 4.3.0 of S-57 Appendix B.1, Annex A, Edition 7.0.0 of S-58 and Edition 2.0.0 of S-99; one Member State offered supportive comments in addition to their vote. These comments are provided in Annex A to this Circular Letter.
