

- 1. Reference A presented the proposal of the Joint CANADA-IHO Project Empowering Women in Hydrography (EWH) and the IHO Secretariat encouraged Member States to consider the recommendation of the 2nd Session of the Assembly (A2 Decision 36) to participate in the EWH Project.

- 3. The Secretariat would like to announce that the EWH project will fund the participation of 8 female candidates to attend the 3rd Session of the Assembly in Monaco from 1 to 5 May 2023. The attendees will gain valuable insight into the workings of the IHO Assembly, the most important organ of the International Hydrographic Organization, develop their network through interactions with world experts in hydrography, will be allowed to participate at the Empowering Women in Hydrography event on Monday 1 May at 15h30 and at the Opening Ceremony on Tuesday 2 May at 10h00. In order to participate in the remainder of the Assembly, the selected candidates will need to be registered as part of an official Member State delegation.

Candidates should complete the questionnaire attached in Annex A and can either submit their applications through the official representative of their Member State or send it directly to ewh@iho.int. The application should include a recommendation and any other relevant information from the official representative of their Member State which could be of use in assisting the Selection Panel in reaching a decision. Candidates' applications should arrive no later than 10 April 2023.
