Dear Hydrographer,

- 1. This Circular Letter is to inform you that the 16th meeting of the Hydrographic Services and Standards Committee (HSSC-16) is planned to be hosted in Tokyo, Japan from 27 to 31 May 2024, thanks to the kind invitation of the Hydrographic and Oceanographic Department, of the Japan Coast Guard (JHOD). Unless meeting logistics change drastically, this meeting will be managed as an in-person event only. However, please note that the feasibility of setting passive live streaming is under consideration as JHOD makes the final determination regarding meeting logistics which will be made in March.
- 2. HSSC-16 is planned to be conducted from 27 to 31 May 2024, as follows:

Registration – Logistic Information

- 3. All delegates intending to participate in HSSC-16 are invited to register through the IHO online registration system (link) **no later than 15 April 2024**.
- 4. A first version of the logistic information for HSSC-16 (as of 8 December 2023), kindly provided by JHOD, is available on the HSSC-16 webpage (<u>link</u>). Those delegates who need invitation letters to facilitate their visa requirements are kindly invited to contact the International Affairs Office of JHOD (<u>iao@jhod.go.jp</u>). It is highly recommended not to wait for the approval of your travel requests at national level for requesting these invitation letters: letters can be provided in advance of travel approvals.
- 5. In this December 2023 version of the logistic information, please note the warning provided in red by JHOD, by which the exact location of the meeting will be decided in March. Two options are in fact under consideration by the host country, both of them in Tokyo: JHOD building in Chiyoda-ku (first choice), or a Conference room in another district (Azabu-Juban). Public transportation is available from the hotels recommended by JHOD, so they can be booked for both options. However, these recommended hotels are certainly closer to JHOD than Azabu-Juban. Another option is to plan refundable reservations in the case the meeting is set in Azabu-Juban area.

HSSC Chair Group meetings

- 6. As indicated in paragraph 2, the plenary meeting sessions will be preceded by a HSSC Chair Group meeting on Monday 27 May. A follow-up meeting of the Chair Group is also planned on Friday 31 May. These meetings will have a special focus on proposals to be submitted to the 8th meeting of the Council, in particular in relation to the S-100 timelines for the approval of Edition 2.0.0 of S-100 Product Specifications.
- 7. In addition to the Chair and Vice-Chair of HSSC, these Chair Group meetings will comprise of the Chairs of HSSC Working Groups (WGs), the Chairs of the Project Teams and the Secretary and the Assistant Secretary of HSSC. If the Chair of an HSSC WG/PT cannot be present at the HSSC Chair Group Meeting and/or at the HSSC Meeting, they are requested to make appropriate arrangements (through their Vice-Chair, Secretary or a representative of any IHO Member State) for the WG/PT to be represented and to inform the HSSC Secretariat accordingly.

Actions arising from HSSC-15

8. The current status of actions arising from HSSC-15 (Reference D), is available on the HSSC-16 webpage (Doc. HSSC16-03A refers).

Draft Agenda and Timetable for HSSC-16

9. A draft provisional agenda/timetable for HSSC-16 is provided in **Annex A**. It takes into account the need for HSSC to provide the Council, at their meeting in October, its initial views and inputs for the revision of the IHO Strategic Plan 2021-2026 in preparation of the next one (2027-2032) to be adopted at the 4th Session of the Assembly in 2026. In accordance with references B and C, the reports and proposals from the working groups and project teams will need to be focused on top priority items related to the endorsement/approval phase of new editions of standards supporting the S-100 Roadmap in particular. Objectives and Actions for

meeting the various deadlines will need to be highlighted in the reports and accompanied by a (low/medium/high) risk assessment².

- 10. Due to these priorities, there is no specific Stakeholders' Open Session for industry, planned this year, with the intention of giving more time for technical discussions, product by product identified in Phase 1 of the S-100 Implementation Roadmap. Thanks to the new version of the HSSC Terms of Reference and Rules of Procedure adopted by IHO CL 02/2024, this should not prevent the HSSC Chair, advised by Working Group Chairs, from inviting subject matter experts and expert contributors (OEMs³, ...) deeply involved in the development of tools, procedures, and software related to the production of S-100-based products and data services, to participate on case-by-case basis.
- 11. Member States and Observers are requested to review the draft agenda and programme and provide any comments or proposals for new or amended subjects to the HSSC Secretariat **by 31 March 2024**. A revised draft agenda and timetable will be prepared and posted on the HSSC-16 webpage subsequently.

Deadlines for HSSC-16

12. Documents intended for consideration at HSSC-16 should be submitted to the HSSC Secretariat in accordance with the "Instructions for the Submission of Reports and Proposals for Consideration by HSSC". With the exception for substantive submissions, it is agreed that the Chairs of the working groups (WGs) and Stakeholders may only provide summary reports, using the HSSC PowerPoint® template and additional comprehensive documents if appropriate (proposals to be endorsed for instance).

- 14. All documents will be posted on the HSSC-16 webpage as and when they are received. Delegates are requested to circulate these documents amongst their relevant subject matter experts and consolidate any appropriate comments to allow effective decision making at the

meeting of the HSSC and avoid, as far as possible, the need to defer decisions to allow further post-meeting technical consultations.

Norway and Poland are kindly invited to confirm their generous offers for hosting these meetings, as well as the dates and venues, **at HSSC-16**.
