Dear Sir,

1. Chair of TSMAD –Dr Christopher DRINKWATER, UK, has indicated that he will soon be retiring and will therefore no longer be in a position to continue as Chairman of the Transfer Standard and Applications Development Working Group (TSMAD) beyond the next TSMAD Meeting (Wollongong, Australia, October 2003). A new Chairman is therefore required for TSMAD and the purpose of this letter is to seek candidates to fill this position. Any volunteer should be conversant with TSMAD work and, ideally, will be a member of the WG. The current TSMAD membership is given in **Annex A**. All candidates will however be considered.

CHRIS Members are invited to nominate suitable candidates for this position. Nominations should be submitted **by 15 May 2003** using the Nomination Form provided in **Annex B**. The IHB will collect the nominations, which will be considered at the 15th CHRIS Meeting (IHB, Monaco, 10-13 June 2003).

2. Attendance at CHRIS-15 – In order to facilitate the practical arrangements for the 15th CHRIS Meeting, CHRIS Members are further requested to indicate whether they will participate in this Meeting, using the Registration Form in Annex C.
