### Update on the development of the IHO GIS and related web-based services

**Executive Summary:** This paper reports on the progress in developing the IHO GIS and related web-

based services.

### General

1. Work has continued since IRCC-8 on the development of the IHO GIS which is composed of two main parts: a country information database and a regional information database.

## Single Interface to IHO GIS applications

2. All IHO GIS applications are now accessible through a single interface of the IHO website at <a href="https://www.iho.int">www.iho.int</a> > Home > IHO GIS. Table 1 lists the applications that are available.

9. The number of areas with no data or with data provided before 2012 represents 34% of the total number of areas listed in C-55 (excluding areas related to land-locked countries). RHCs are invited to ensure that entries related to their region are updated on an annual basis and that the appropriate updates or reports of no change are provided to the IHB. This can be done through national reports to RHC meetings in accordance with the IHO Resolution 2/1997 as amended - *Establishment of Regional Hydrographic Commissions (RHC)*.

### **Regional Information Database**

- 10. Work has continued on developing GIS outputs derived from C-55 data. They are available only for the internal use of the Secretariat.
- 11. Following the investigation of portrayal options for CATZOC data, the RENCs were invited to seek the approval of their members for the IHO Secretariat to brief RHC meetings with composite CATZOC reports. The Chair of the WENDWG was requested to report at IRCC-9 on this issue (see action WENDWG7/09).
- 12. The IHO HCA GIS information system is currently under review by the HCA Members and Observers. The objectives are:
  - to investigate the possibility of adding vessels traffic patterns for improving risk-assessment against the status of surveying and charting in the region (see action HCA14/07).
  - to experiment a data discovery mechanism using interoperability with other national geoportals (see action HCA14/12)
  - to assess the existing data layers and the associated maintenance procedures (see action HCA14/15).

# **IHO ENC Catalogue**

13. The further enhancement of the IHO ENC Catalogue is in progress with the aim to include all ENCs available and identify how they are distributed in accordance with the actions agreed at the WENDWG6 meeting. It is expected that an enhanced version of the Catalogue will be available for consideration at IRCC-9.

### INT Chart Web Catalogue and Associated On-Line Web-based Services (INToGIS)

14. The INToGIS application seems to work well.

### **On-Line Registration Service for IHO Meetings**

- 15. The on-line registration service for IHO meetings developed with the support of the Republic of Korea (KHOA) was used successfully for the 8<sup>th</sup> HSSC meeting and for the 1<sup>st</sup> session of the IHO Assembly. A set of upgrade requirements based on the lessons learned is being developed for further consideration with KHOA.
- 16. On-line registration is now the preferred mode of registration for the meetings organized by the Secretariat.
