Considering as Pending.	In terms of harmonization it cannot be adopted as Plain, because such generic term is not included in B-6. I propose to get it PENDING for some discussion.	I am very much reluctant to accept it as a PLAIN even though it is an old, historical name. For me, the areal extent is too small to be called as PLAIN. It is more like a TERRACE for me. If you see the Cook 1968 chart, the New Caledonia Basin is much bigger than the Rakumara Plain. This is weird for me.	I agree that it looks more like a terrace, but the term plain has been in long term use. There are 3 other plains in the Gazetteer (Alaska, Gascoyne and Mascarene) although these are more abyssal plains. Accept or not, Raukumara Plain is already in the GEBCO gazetteer – The proposal was to provide more information and coordinates.
