IHO INTRODUCTION / BACKGROUND

International Hydrographic Organization We need an environment where many stakeholders can cooperate to

facilitate wider implementation of S-100

- KHOA and CHS came up a way forward to bring together domestic organizations for S-100 implementation
- HENCE the establishment of a National S-100 Committee!



IHO COMPOSITION AND WORK OF THE NATIONAL S-100 COMMITTEE

- Composition of national S-100 committee
 - Various national stakeholders
 - ✓ maritime administrations, research institutes and industry in the fields of nautical publications, aids to navigation, e-Navigation and marine weather
 - Regular meetings, ad hoc meetings and seminars
- Work
 - (Canada) The objective is to develop national S-128 catalogue of services, share knowledge and build momentum within the country to meet S-100 roadmap targets
 - (ROK) We share the status of the development of S-100 standards, actions nationally executed by domestic organizations, product distribution connections between organizations and other S-100 related topics from international meetings



IHO CONCLUSION

- We understand the progress on the development of different standards and create an opportunity to encourage discussion and cooperation.
- A plan for cooperation among different fields in the development of standards was set up.
- If there are other IHO MSs who run similar committees, it would be useful to share such activities so that many MSs can make preparations for the implementation of S-100.
