IHO Secretariat's preliminary managerial, technical, financial and administrative considerations on the establishment of IHO Infrastructure Centre

Executive Summary:	The IHO Infrastructure Centre proposal outlines a detailed ac- count of potential responsibilities for the Centre with estimated resources. It also acknowledges the challenges regarding im- plementation within the IHO's administrative framework. This paper provides the Secretariat's first analysis on the basic divi- sion of roles between IHO Headquarters and the proposed Cen- tre, an estimate of what will need to be addressed in M1, M3, and M7, and the Secretariat's interpretation of the schedule for Centre implementation should the Council agree.

Introduction/Background

- 1. Council decision C7/09
- 2. Documents: C8-04.1A, C8-04.1A and HSSC16-04.5A
- 3. The implementation of S-100 brings great opportunity for the IHO's Member States, but its success depends on the IHO Secretariat taking on a more operational role in terms of S-100 technology infrastructure. During the IHO's Standards evolution from paper charts to S-57 and now S-100, a few of its Member States have been responsible for managing large parts of the supporting infrastructure for IHO standards. The proposal offered by the Republic of Korea presents an opportunity to establish a sustainable solution for supporting technology infrastructure that is critical for the long-term success of S-100 that is managed by the IHO Secretariat, and potentially beyond the S-100 standard.
- 4. Based on the recommendations provided by the S-100 Infrastructure Centre Establishment Project Team, which recognized that the success of S-100 is dependent on a sustainable supporting infrastructure and weighed alternate solutions for such support, HSSC 16 agreed to seek approval from the Council for an interim status of the Centre followed by a permanent establishment to be decided by Assembly 4.
- 5. In order to support the establishment of the proposed Centre, the IHO Secretariat kindly offers its expectations regarding the basic division of roles between IHO Head-quarters and the proposed Centre, an estimate of what will need to be addressed in M1, M3, and M7 should the Member States agree to establish an IHO Infrastructure Centre, as a Technical Division of the IHO Secretariat outside the Principality of Monaco, and the Secretariat's interpretation of the schedule for Centre implementation.

Analysis/Discussion

- 6. As defined in the IHO Convention under Article I, the "Seat" of the IHO shall be the Principality of Monaco, in which the Secretariat and its staff are located and work for the Member States.
- 7. The Secretariat's basic understanding of Centre operations and position as part of the IHO Secretariat: (version to be included in MOU/SLA)
 - The Centre <u>would be</u> function as a "branch", "division", or "field" office of the IHO Secretariat and may be responsible for developing and managing the lifecycle of operative IHO technology infrastructure such as:
 - Open-source platform supporting Product Specification development, maintenance, and support
 - Quality control and secure delivery of S-100 catalogues and S-164 test datasets
 - The IHO Geospatial Information Registry and S-100 toolkit
 - S-100 Catalogue distribution, quality control and testing
 - Support for navigation system type approval
 - IHO data protection scheme (S-63 and S-100 Part 15)
 - Github standards collaboration management
 - INToGIS
 - GIS Support
 - IHO E-learning system
 - Development and maintenance of associated training and documentation
 - The Centre <u>would not</u> host functions that are considered that of the IHO "seat" including: *
 - Organizational Governance Secretary General and Directors to set the strategic direction of the organization, ensure compliance with IHO governing documents, ensure ethics and accountability, and major decision making.
 - Operations Management Coordinate the operational functions for the organization and ensure that different divisions are working together effectively. This includes the management and coordination of the IHO Assembly, Council, and other IHO bodies.
 - Finance Central control over all finances, budgeting, accounting, reporting, etc.
 - Human Resources Recruitment, employee relations, and benefits administration
 - Marketing Branding, advertising, etc.
 - Public Relations Maintain the organization's public image and presence in the larger hydrographic community
 - Internal Communications All communications to employees
 - Information Technology Management of IT policies and procedures to ensure security and compliance with international standards and regulations
 - Translation Official IHO translation of all documents and publications
 - Legal Decisions regarding legal issues

 Official Archive – The official archive of the IHO shall be in Monaco. Recognizing that the Centre may manage and develop working versions of standards, manuals, and specifications, official versions of all documents shall be deposited in Monaco. If digital, Monaco shall retain control and ensure accessibility for all MS.

* All functions listed will be managed by the Secretariat in Monaco for the Infrastructure Centre

Recommendations

- 10. The Secretariat is greatly appreciative of the ROK proposal and recognizes the significant opportunity that it offers the IHO and its Member States. Following the HSSC/ICE PT's recommendations, the Secretariat also recognizes that for the IHO to provide sustainable operational support for the S-100 Universal Hydrographic Data Model and other technology-based infrastructure, the Centre's implementation is the only known viable option toward mid- and long-term support for S-100 technology infrastructure.
- 11. The generous offer and engagement of the Republic of Korea for funding the IHO Infrastructure Centre (level still to be defined), at least until 2035, is a strong argument to be considered. The IHO Secretariat recommends that a formal confirmation on the level and duration of engagement is formalized by an official letter issued by ROK no later than HSSC-17.

Justification and Impacts

12. The Secretariat is acutely aware that implementing this type of transformation will significantly impact the IHO's governing documents. However, the investment in ensuring that IHO governance recognizes a distinct clarification of responsibilities between the IHO's headquarters, and a subsidiary office will reduce the potential for future misunderstanding. It is also important to ensure that the IHO agrees with the timing of the Centre's implementation as S-100 will be increasingly dependent on its technology infrastructure to function properly.

13. The main immediate impact will be the time that it takes IHO Staff and Member States to ensure that all documents are drafted and updated in accordance with agreed timelines for implementation.
