Decision A3/8(e)

The Assembly tasked the Council with the development of the revised Strategic Plan (SP) to be put in place for 2027-2032 in compliance with the Planning Cycle and to submit the result for adoption by A-4 in 2026.

Decision C7/36

The Council acknowldge that the current structure of the SP 2021-2026 was still relevant at conceptual level, and agreed that the objective for the next SP 2027-2032 shuld be limited to a revision of the current SP.

Decision C7/38

The Council welcomed the offer from the Council Vice-Chair to lead a Correspondence Group on the ways and means to prepare the next IHO Strategic Plan 2027-2032.

ACTIVITY OF THE CORRESPONDENCE GROUP WAYS AND MEANS TO PREPARE THE NEXT IHO SP

International Hydrographic Organization

- Started its activity last November, with members consisting of BR, DE, DK, FR, GB, HR, JP, NO, NZ, SE, SG and US.
- Considered ways and mean to prepare the next IHO SP, taking into consideration that the next SP;
 - should be limited to a revision of the current SP
 - will be developed using a bottom-up approach
 - should be prepared in a short term (by Dec. 2025)
- Agreed to establish the Strategic Plan Review WG (SPRWG) and prepared its draft ToR, RoP and timeline for.


Drafting Phase

- ✓ revise the existing goals and targets (if needed)
- \checkmark define the criteria for measuring success
- ✓ consider the interrelation of the revised SP to other management
- ✓ prepare a draft SP for HSSC17 and IRCC17
- ✓ revise the draft SP iaw the results of HSSC17 and IRCC17, and provide the final draft to C-9
- ✓ support Council's submission of a proposal on the IHO SP 2027-2032 to A-4

DISCUSSION ROP OF SPRWG (ANNEX A)

International Hydrographic Organization

- The WG is open to all Member States.
- The Chair and Vice-Chair of the WG shall be nominated at the end of C-8 and the nominations shall be determined by vote of the Council Members present and voting.
- The Secretary, to be decided at C-8, shall prepare the reports required for submission to C-9 and to A-4 as directed by the Council.
- The WG should normally work by correspondence.
- Recommendations to Council shall generally be made by consensus.
- The WG will be disbanded after A-4 and the inputs from Assembly will be implemented into the proposed draft SP, if appropriate.



DISCUSSION RECOMMENDATIONS

International Hydrographic Organization

1. To establish SPRWG with its proposed ToR, RoP and timeline table to efficiently and effectively revise the current IHO SP.

2. To select the Chair, Vice-Chair and Secretary of SPRWG for enabling its early actions after C-8, if the establishment of SPRWG is approved.

b) approve the establishment of SPRWG.

c) select the Chair, Vice-Chair and Secretary of SPRWG.

d) endorse ToR and RoP of SPRWG as presented in Annex A.

e) notify SPRWG to consider the timeline in Annex B.

f) task the IHO Secretariat to issue an IHO Circular Letter to call for comments on ToR and invite the Member States to SPRWG at the earliest possible time after C-8. SPRWG will start its relevant activity on 1 November 2024.

g)take any other action if appropriate.
