# CALL FOR COMMENTS ON THE PROPOSALS TO BE CONSIDERED AT THE 8<sup>th</sup> MEETING OF THE IHO COUNCIL (C-8)

- 1. As reported in Reference A, the 8<sup>th</sup> Meeting of the IHO Council (C-8) will be held at the IHO Secretariat in Monaco from Tuesday 15 to Thursday 17 October 2024 as a face-to-face event with passive livestreaming arrangements on request.
- 2. it is proposed to hold C-8 for two days and a half through five plenary sessions as depicted in the table below.

- 3. This Council Circular Letter is also to remind you that, in accordance with Reference B (Rule 7 refers), the deadline for submitting proposals is **15 July 2024**. All documents received after the deadline will be considered as information papers only.
- 4. In order for the IHO Secretariat to prepare the C-8 *Red Book* and make it available on the C-8 webpage **at least two months before** the opening day of the meeting of the Council (in accordance with Reference B), Member States are invited to monitor the updates made on the list of proposals on the C-8 webpage on a regular basis and to forward any comments that they may have, so they reach the IHO Secretariat (by e-mail: <a href="cl-lc@iho.int">cl-lc@iho.int</a>, Word version in arial font preferable or converted pdf file) **no later than 5 August 2024** ("...ten weeks before the opening...", in accordance with Reference C, paragraph 1).
- 5. To facilitate the preparation of the organization of C-8 and based on the experience from previous Council meetings, Member States having a seat at the Council are also invited to nominate rapporteurs by email to: <a href="mailto:yves.quillam@iho.int">yves.quillam@iho.int</a>, by 5 August 2024. Instructions for rapporteurs will be provided on request. For planning purposes, it should be noted that the rapporteur(s) in charge of Thursday session 5 may need to work with the IHO Secretariat until Friday afternoon (close of business), when the summary report/proceedings from the préciswriters for these two last sessions become available for checking and validation.
