

**ACCEPTANCE OF CROWDSOURCED BATHYMETRY ACTIVITIES AND PROVISION OF RESULTANT DATASETS
IN NATIONAL WATERS OF JURISDICTION**

1. Based on the comments received to the questionnaire in Annex B to IHO CL 11/2019 and to the questionnaire in Enclosure to IHO CL 21/2020, the following table is published as the Positive List to guide potential data gathering and provision activities undertaken by the wider maritime community in waters of national jurisdiction:

2. Under normal circumstances, whether there is a requirement to inform the relevant Hydrographic Office of new data or to provide a copy of the dataset, this will be undertaken by the Trusted Node to which the dataset has been submitted. The IHO Data Centre for Digital Bathymetry (DCDB) will apply a geographic screening process to all data received and will store datasets from restricted areas in a restricted non-public database until such time as the appropriate authorizations have been received for placing it into the public domain.

3. Under all circumstances, and in line with current practices, any variations, errors or additions to the information published on official charts or in the associated nautical publications should be brought to the attention of the relevant Hydrographic Office by the quickest means available. The continued use of the known *Hydrographic Notes* procedure as the method of forwarding information is encouraged.
