1. Overview/Introduction

At GGC39, the subcommittee on education and training SCET was established and an inaugural chair and vice chair were elected, namely Paul Brett from Canada, and Rochelle Wigley from USA. SCET met on several occasions between receiving formal approval and GGC 41. These meetings were designed to formulate a general direction for SCET in its early years.

SCET held its first formal subcommittee meeting on 26 OCT 2022 where a workplan for 2023-2024 was discussed and agreed upon. SCET held an open conversation with the GEBCO community at this time to further direct the subcommittee in its direction.

SCET continues to build and enhance its membership but is struggling to move forward on many of the actions of the workplan due to the busy lives of the the committee membership.

We have started working on the database of training related to ocean mapping and will do more over the next year.
