Executive Summary:	This document reports on the monitoring, since SCUFN-34 (VTC01, 02 & 03) and SCUFN-35.1, of the PENDING names from the on-line GEBCO Gazetteer database. These include all new PENDING names agreed at SCUFN-34 and SCUFN-35.1.

### Introduction / Background

1. Following the three SCUFN34 meetings, held via video-teleconference (VTC) in 2021, and the SCUFN35.1 meeting in March 2022, considering the limited resources available within its Sub-Committee, the Secretariat of the GEBCO Sub Committee on Undersea Feature Names (SCUFN) decided to contract several tasks in order to improve the content of the IHO-IOC online GEBCO Gazetteer of Undersea Feature Names (the Gazetteer) and support SCUFN activities managed by the IHO Secretariat. The following tasks were contracted to the former SCUFN Secretary.


### **Analysis/Discussion**

- 3. A "pending name" is an undersea feature name that was submitted to, and considered by SCUFN, but was not accepted, either due to lack of bathymetric evidence for the feature, or because the proposed specific name is questioned, or following a conflict in naming the feature that must be solved by the authorities involved. The name is kept pending until further information or data is provided by the proposer or an agreement is reached between relevant authorities.
- 4. Document SCUFN34-07.2D (Rev1) reported that, as of October 2021, there were 77 Pending names in the Gazetteer. This number has increased dramatically over the past year since most of the numerous new proposed names during the pandemic could not be dealt with on the occasion of SCUFN meetings that had to be held via videoconferences and in a reduced format. Annex A provides the status of all actions and decisions from SCUFN-34 (VTC01, 02 & 03) and SCUFN-35.1, relating to pending names.
- 5. As a result, the number of pending names has now (September 2022) raised to 205. Annex B provides details of the current list of pending names, including comments on the actions in progress. Annex C lists those 62 names which have been removed from the previous list of pending names, including details on the actions taken. Many of the removed names fell under the terms of Action SCUFN32/188 (August 2019), subsequently taken up by Action SCUFN33/47 (November 2020), which states: "In general, a pending name would remain pending in the absence of any progress or notification of interest, for the following two years, and then would be eliminated from the reserve section of GEBCO Gazetteer". Very often, Action SCUFN32/188 (SCUFN33/47) applies to names relating to conflicts in naming a given feature, which resolution would require consultation between the authorities involved, in accordance with B-6 (Art. I.E). However it looks like this rarely happens and, consequently, little progress, if any, is made to further such issues.

#### Recommendations

It is recommended:

- 7. That SCUFN Members review the other pending names at Annex B, noting the comments in the right-hand column, and conclude on the best way forward for each name.
- 8. That SCUFN Members consider Annex A and Annex C, and comment as appropriate.
- 9. That as many pending names as possible be processed by correspondence, with a view to reduce the list and to avoid congesting future SCUFN meetings.

### **Justification and Impacts**

10. Regulating SCUFN intersessional work by correspondence, through a new Rule of Procedure, aims to put on an equal footing, decisions taken at meetings and by correspondence. Implementation of Decision SCUFN32/188 (SCUFN33/47) clearly helps reducing drastically the number of conflicting pending names, as well as limiting their proliferation.
