Subject: 5th HCA Meeting, Christchurch, New Zealand, 2-4 November 2005

Dear Sir or Madam,

We have received confirmation from Mr. John SPITTAL, National Topographer / Hydrographer of New Zealand, that the 4th Meeting of the Hydrographic Commission on Antarctica will be held in Christchurch, New Zealand, on 2-4 November 2005. A provisional agenda for the meeting is proposed at **Annex B**. You are kindly requested to review this draft and to provide your comments / suggestions for changes **before 30 June 2005**. A revised agenda will then be prepared, as well as an annotated agenda giving a brief explanation for each item; their sending to HCA members will be the subject of a further HCA Letter.

The Venue:

The meeting will take place at the Antarctic Centre, which is about 5 km from the centre of Christchurch but only a few hundred metres from the international airport. The Antactic Centre is part of an Antactic Museum and attached to the complex where all travellers to McMurdo and Scott Bases depart from. Mr. Spittal has indicated that a formal dinner will be arranged, probably at the Antarctic Centre. Also, that Huskies are usually brought along for delegates to see and rides are provided in tracked ice vehicles. It will be Spring in November so the temperature should be cool to warm, approximately 10 to 15 degrees during the day and about 5 degrees at night.

Hotel Information:

Proposed accommodation is described at **Annex C**. The three proposed hotels are all very close to the Antarctic Centre. It is advised to make the reservations fairly early as October / November is a very busy time for conferences in New Zealand. It should be stressed that only the signatory HCA members attending the 5th HCA meeting will be entitled to vote, should the need arises during the meeting. Therefore those HCA members² who have not yet signed the HCA Statutes are urged to do so <u>at their earliest convenience</u>, by sending a copy of the HCA Statutes, duly signed, to the IHB.

Status of ENC Production in Antarctica

According to Action 12 from HCA/4, the IHB was requested to prepare a draft table showing the ENC production status for Region 'M', based on the INT Chart Scheme, and to circulate it to HCA Members, for consideration, comments, and completion.
