

44th ANTARCTIC TREATY CONSULTATIVE MEETING BERLIN, GERMANY 23 MAY TO 2 JUNE 2022

SECRETARIAT NOTE 1: PRELIMINARY AGENDA, EXPERTS AND KEY DATES

25 October 2021

Germany is delighted to host the 44th Antarctic Treaty Consultative Meeting (ATCM XLIV) and the 24th meeting of the Committee for Environmental Protection (CEP XXIV). The meetings will take place in Berlin, from 23 May to 2 June 2022, at the ESTREL Conference Center.

The current situation of the COVID-19 pandemic and advances in worldwide vaccination suggest that regular international travel and public gatherings might be possible in May 2022. Therefore, Germany is organizing, in close cooperation with the AT Secretariat, ATCM XLIV as a regular in-person meeting. In parallel, it is establishing contingency planning in the case that unforeseen events lead to the modification or cancellation of the in-person meeting in Berlin. Independently of this, Germany is also exploring the possibility that members of delegations are registered and authenticated to participate remotely at ATCM XLIV. In the case of an in-person meeting, however, the possibility to request the floor could be restricted to delegates who are physically present. Germany proposes to discuss this topic at a virtual Heads of Delegation Meeting to be held at the beginning of December 2021.

At ATCM XLIII in Paris Parties agreed upon the preliminary agenda as well as the proposed schedule for ATCM XLIV (Attachments 1 and 2). Germany reminds Parties that according to Rule 37 of the ATCM Rules of Procedure, the deadline for proposing supplementary agenda items (for both the ATCM and the CEP) is 180 days before the meeting. For ATCM XLIV and CEP XXIV this deadline **is Wednesday, 24 November 2021.** Germany also reminds Parties that in accordance with Rule 40 this is also the deadline for proposals to invite additional experts from other international organizations to attend ATCM XLIV.

You will find in Attachment 3 other key dates, including important deadlines for the submission of documents for consideration at the ATCM and CEP.

Furthermore, Germany has the honor to inform you that Dr. Manfred Reinke has been appointed Head of the Host Country Secretariat and Dr. Marco Gogolin Deputy Head of the Host Country Secretariat.



ATCM XLIV is jointly organized by the German Foreign Office and other ministries and institutions, in particular the Federal Ministry for the Environment, the Federal Ministry of Education and Research, and German universities, scientific institutions und institutes.

Germany is working closely with the Antarctic Treaty Secretariat to provide efficient arrangements for ATCM XLIV and an enjoyable experience for delegates.
