# Directive on "open data and the re-use of public sector information" - Sharing information

Gilles Martinoty is Shom's representative in the French working group concerning the implementation of the directive on "open data and the re-use of public sector information".

He presented the state of the current negotiations concerning the identification of "high value datasets", that will have to be delivered free of charge, with an open-data license (probably the CC-BY 4.0 license, that allows all uses), and through an API. (IENWG 10 2B)

## Some key points:

- An expert committee has been created with representatives of each member State (list of members IENWG 10 2F). It is recommended to contact your expert and explain your situation (For example, in Italy, the expert was invited to visit the IIM and understand the risks for the business model of the HO).

Meetings are organized every six months till mid-2021, the next one will take place in May 2020.

- *The list of high value datasets* approved by the EU will be mandatory for all member States (MS).
- *A MS can open other datasets* in addition to the common list validated at the EU level, but will not be allowed to restrict access to EU approved high value datasets.

As a consequence, a consensus has to be found for marine charts to be put, or not, on the list of high value datasets. If a majority of MS agree on putting them on the list, one government will no longer be allowed to remove its marine charts from a national list, it won't possible. Thus, the opinion of each MS on marine charts is essential.

- Information from the Danish data agency: a study on the socio-economic value of data and products produced by the HO was carried on by Deloitte consulting company, in order to assess if releasing them as open data would have a significant impact (IENWG-10 2C).

The results showed that the economic value mainly lies in (high-density) bathymetric data. The point of the Danish HO is that these products don't have a high economic value for private companies. The summary of the document in English was provided by the Danish HO for IENWG members.

Recommendations from the working group;
