### Standards and Best Practices in Ocean Observation Contract Service OBJECTIVES

- The objective of this tender is the development and testing of an information system for assembling and disseminating best
  practices and standards in ocean observation. This should be user-friendly to easily identify, access, and utilize best practices
  and standards in the field of ocean observation.
- "Ocean observation" encompasses all in situ observations of the state and dynamics of the ocean and its physical, chemical and biological components within and beyond the jurisdiction of EU Member States, with the exception of observations made from Earth-orbiting satellites.



• One further objective of the information system is to facilitate to streamline and promote the use of the commonly-used and community recognized best practices and established standards, as well as to enhance the quality and consistency of sampling, analysis, measurements, data processing and management, and other applications within the field of ocean observation.



WP1 Literature/Assets Collection and analyses, and system level requirements

- ✓ Objective:
- Identify sources of existing Best Practices and Standards and analyse them
- Develop a classification and nomenclature for the type of standard or best practice.
- Determine metadata for the standards and best practice that facilitate discovery
- Identify standard that are already European or international standards
- Identify best practices with details for completeness, acceptance, established and documented through EU processes
- Identify areas where there are overlapping or duplicated standards or best practices
- Identify areas where a request could be made for standard under the Union work programme for European standardization
- Prepare a short summary of each standard or best practice identified



- Sources from Ocean Best Practices System Repository, Regional Sea Conventions Monitoring Guidelines,...
- Implemented ontologies and controlled vocabularies
- Endorsement methodology developed by OBPS/GOOS.
- Maturity levels identification schema developed in the framework of JERICO-S3.
- OBPS metadata and document guidelines for approved practices and standards
- FAIR and CARE Principles guidelines.
- Standards organization policies for access to their standards.
- European policies for standards and best practices.
- Open access guidelines (CC BY, etc).
