# 6.1 SWPHC Work Plan 2022-2023: A regional plan to deliver the Goals of the IHO Strategic Plan and the SWPHC (see Annex A)

The full Work Plan is contained in Annex A and highlights activities completed since its instigation. The following items highlight key activities from the workplan that the SWPHC wish to bring to the attention of the IRCC.

6.1.1 <u>SWPHC Goal</u>: Increase SWP influence at IHO and other international/intergovernmental bodies.

# 6.2 Investigation of UN-GGIM Integrated Geospatial Information Framework (IGIF-H)

SWPHC20 meeting (February 2023) included sessions on the UN-GGIM IGIF focusing on building partnerships and understanding the World Bank; and implementation case studies from the Philippines and Kiribati.

### 6.3 Regional collaboration on Safety of Navigation, delivering as one

SWPHC20 included a session on <u>Safety of Navigation: Delivery as one</u> with contributions from IHO, IMO and IALA. This led to an action for IHO, IMO and IALA to work together with the SWPHC and the Pacific Community (SPC) to address the capacity building needs of the Member States in the SWP region.

### 7. SWPHC cooperation with stakeholders (organizations, industry, etc.):

 Seven Expert Contributors attended SWPHC20 and made presentation on topics such as capacity building, industry update on LiDAR, SDB and contribution to Seabed 2030, rising demand for large scale, high density ENCs and aspirations for coverage and quality of ENC in the region.

# 8. Difficulties encountered and challenges yet to be addressed

The main challenges (now and yet to be addressed) in the region are:

- Engaging and coordinating with international and regional agencies, development partners and coastal states at a senior enough level, to raise awareness of the benefits of hydrography and adopting and giving effect to open data policies and mutually agreeable practices. (ref: IRCC14-06.1I: SWPHC substantive paper) See <u>DECISIONS OF THE 3rd SESSION OF THE IHO ASSEMBLY – Decision 20</u>
- Supporting hydrographic governance in Pacific Island Countries and Territories with the introduction of S-100 Next Generation Charting Products & Sunsetting of the Traditional Paper Chart.
- Provision of mechanisms to ensure greater inclusion and participation of SWPHC Member States at IHO meetings, in particular the IHO Assembly (SWPHC20 Action 21). (Ref: 3-Day SWPHC20 Meeting, Agenda Item 7, Draft Minutes V1.0.) See <u>DECISIONS OF THE 3rd SESSION OF THE IHO ASSEMBLY – Decision 21</u>

# 9. Achievements and lessons learned:

- SWPHC allocated two seats on IHO Council (CL 43/2022, 7 November 2022). Fiji and New Zealand are designated as the SWPHC Representatives to the Council. Fiji is the first Pacific Island Country to be designated a seat on Council.
- SWPHC18 (2021) Coastal States provided a high-level gap analysis for each goal of the Strategic Plan to develop the SWPHC Work Plan.
- IRCC14-06.11 <u>SWPHC substantive paper</u> recommending the development and implementation of a strategy to engage with international and regional agencies, development partners and coastal states to support knowledge and understanding of hydrography and the value associated with open data policies in respect of marine geospatial information.
- <u>SWPHC paper and presentation of IHO Strategic Plan and SWPHC Work Plan</u> to the Pacific Regional Maritime Transport Officials Meeting, November 2022. The paper

requested the meeting to engage and collaborate with IHO, IMO, IALA and regional partners to deliver as one the delivery of future Safety of Navigation services in the Pacific region.

- The SWPHC Vice-Chair, Lt Cdr Jervis Robinson (FJ), attended the 5<sup>th</sup> Pacific Regional Energy & Transport Ministers Meeting (5<sup>th</sup> PRETMM) May 2023. The above SWPHC paper was provided to the Transport Ministers for information and an intervention was presented by the SWPHC Vice-Chair (FJ) on behalf of the IHO. SPC presented their *Regional Strategy on Safety of Navigation 2023-2027* requesting regional agencies and international development partners to coordinate their interventions and efforts through this regional strategy.
  - Information Paper <u>TI 06: The International Hydrographic Organization (IHO)</u> <u>Strategic Plan 2021- 2026 and the South West Pacific Hydrographic Commission</u> (SWPHC) Workplan
  - Partners Dialogue, IHO Intervention (Annex B)
  - SPC <u>Regional Strategy on Safety of Navigation 2023-2027</u>
- SWPHC19 meeting (February 2022) included a session on the UN-GGIM Integrated Geospatial Information Framework (IGIF) & Open Data the value proposition.

The intent was to kick-start a regional discussion on the value and benefits of geospatial information, the framework and sharing data. The outcome is to seek actions and commitment from SWPHC members to collaborate with international and regional entities and coastal States to develop a strategy to support the implementation of the IGIF, understand the value of open data and commit to sharing data.

- The Hydrographic Leaders Programme (HLP) was launched in February 2022. It is a direct response to the **SWPHC Goal 1** *Increase SWP influence at IHO and other international/intergovernmental bodies*. Sixteen participants from 12 countries took part in the HLP.
- The first meeting of the SWPHC MSDIWG was held February 2021 and the WG held its 10<sup>th</sup> meeting in April 2023. The main focus areas of the WG is the development of a <u>data sharing proposition</u> (presented at SWPHC20); encouraging Coastal States to share data and adopt open data policies; and adopt and implement the UN-GGIM Integrated Geospatial Information Framework-Hydro (IGIF-H).
- A SWPHC Empowering Women in Hydrography Pacific Network was established in September 2022 to build relationships and support career growth through mentoring, opportunity, and awareness. Fifty-five women have joined the network to-date from around the region as well as from the UK and US; and work in national hydrographic offices, maritime safety authorities, navies, Government science organisations, industry and academia.

- SWPHC20 meeting (February 2023) included sessions on the UN-GGIM IGIF focusing on building partnerships and understanding the World Bank; and implementation case studies from the Philippines and Kiribati.
- SWPHC20 also included a session on *Safety of Navigation: Delivery as one* with contributions from IHO, IMO and IALA. This led to an action for IHO, IMO and IALA to work together with the SWPHC and the Pacific Community (SPC) to address the capacity building needs of the Member States in the SWP region.
- Members are active on IHO committees and working groups but face challenges of attending in-person meetings due to distance and prohibitive travel costs.

### 10. Conclusions:

The SWPHC continues to actively deliver an extensive work plan of engagement and collaboration with other international, regional and bilateral partners to deliver to the IHO Strategic Plan objectives and goals.

Given the SWPHC intervention at the 5<sup>th</sup> PRETMM and the commitment by IHO, IMO and IALA to *deliver* as *one* at SWPHC20, there is an increasing need for closer engagement with SPC, IMO and IALA. This will need to be prioritized in the SWPHC Work Plan with appropriate resourcing and funding, yet to be identified.
