

- May 30-31, 2024 St John's Newfoundland & Labrador, CA
  29 participants representing 9 agencies hybrid
- Signed agreement defining options and means for resolving transboundary chart schemes (see USCHC47-17)
- Update on S-100 status and planning- deepening our awareness of US and CA strategies (USCHC47-03B and 03D)
- Toward a regional cooperation plan in the Great Lakes
- Increasing convergence on C-55 approaches (USCHC47-16) and hydrographic risk assessment methodologies (USCHC47-19)



## **IHO** Important Findings (RHC top 3 challenges)


- Successful meeting with strong shared bilateral vision, but there is lot of work to do...
- Limited resources- working to leverage each others efforts
  - Fostering programs and plans to support workforce development
  - Finding organizational efficiencies in midst of change
- Ongoing deliberation on a vision of the future of the paper chart
- Approval of the S-101 Standard
- Discussion of Strategic Plan (2027-2033)
- Data from over 65 multibeam bathymetry surveys from the USCHC region were added to the DCDB database since June 2023.



- Intersessional engagement will be criticaltimelines and deadlines
- New leadership and staff, transparency, good mutual understanding to work through challenges we both face
- Starting to document roles and responsibilities for a USCHC S-100 champion
- Started raising awareness of Marine Protected Areas (S-122) in the USCHC "Region A"- ProtectedSeas.org inventory, US National Marine Protected Area Center, and other (see USCHC47-06)
