Gulf of Guinea (GoG)

- √ >6000 Km coastline from Cape Verde and Senegal to Angola
- ✓ Very important shipping zone (oil, gas and goods)
- √ > 1500 vessels every day
- ✓ Piracy, armed robbery at sea, kidnapping of seafarers, IUU fishing, smuggling and trafficking
- ✓ Threat to maritime security in the GoG means threat to the economic development of the entire region
- ✓ In 2020 (according IMB):
 - ✓ 84 attacks on ships
 - √ 135 seafarers kidnaped for ransom
 - √ > 95 % of all kidnappings for ransom at sea



Threat response

- ✓ EU and GoG countries share economic and commercial interests affected by insecurity in the region
- ✓ The EU is committed to improving maritime security in the GoG
- ✓ Large and complete set of projects
- ✓ Focus on the legal framework, training and operating, capacity building, information sharing
- ✓ Funding comes from Instrument contributing to Security and Peace (IcSP) and the European Development Fund (EDF).
- ✓ SWAIMS Project Support the implementation of the Economic Community Of West African States (ECOWAS) Integrated Maritime Strategy

SWAIMS

Improve maritime security and safety in the Gulf of Guinea and Implement the ECOWAS Integrated Maritime Strategy

- ✓ Program launched in 2019 and funded by the EU
- ✓ Implementation period: 2019-2024
- ✓ Beneficiaries: ECOWAS Countries and Mauritania
- ✓ Financing: 29M EUR
- ✓ Managed from Abuja, Nigeria
- ✓ Main Interlocutors:
 - ✓ ECOWAS; EU Delegation in Abuja (EUD); UNODC; Interpol; GIABA; SWAIMS Steering Committee (SC)





SWAIMS

Two specific goals:

1. Strengthen institutional governance and law enforcement frameworks and more success in prosecuting and punishing maritime crimes.

Strengthen law enforcement operational and response capacities.

- ✓ Taught in mother language (EN/FR/PT)




