Dear EAtHC Colleagues,

It is my pleasure to invite you officially to participate in the 17th Eastern Atlantic Hydrographic Commission (EAtHC), which will be hosted by the Instituto Marítimo e Portuário de Cabo Verde (IMP-CV) in Mindelo, Cabo Verde, from the 28 to 30 September, 2022.

An IHO Funded 2-day Seminar on "Working with NAVAREA II and your Primary Charting Authority (Data exchange)" will precede the 17th EAtHC Conference.

1. Provisional Agenda

2. Registration

While I hope that many of you will be able to attend in person, I acknowledge that some will be constrained by national COVID-19 pandemic restrictions and may be unable to attend. Wishing to hold an inclusive meeting, the EAtHC17 plenary and the Seminar will therefore be in a Hybrid format to allow all to attend.

I now kindly ask you to register via the Online Registration tool on IHO website: https://online.iho-khoa.kr/registration.

Please register **no later than 30 June 2022**, for participants who intend to be physically present, and no later than **30 July 2022** for those unable to travel who will participate by VTC.

Early registration is critical to enable our hosts, IMP-CV, to finalise the venue and associated facilities. If you experience difficulties accessing the online registration, please forward your registration details to the EAtHC Secretary at dt.hi.chf@hidrografico.pt.



A VTC invitation will be sent out to all participants in advance of the Seminar/Conference and a test VTC will be set up prior to the meeting to check connectivity and communications.

3. National Report

I would like to encourage all members to submit a National Report no later than 26 August 2022. It helps us to understand better the issue within the region so that we may develop ways of resolving them. on the template/structure as documented the IHO **EAtHC** webpage (https://iho.int/en/eathc17-2022) for both the report and the presentation.

4. Seminar on Working with NAVAREA II and your Primary Charting Authority (Data exchange)

a) Seminar

- The 2022 Capacity Building Work Programme of the International Hydrographic Organisation (IHO) provides support for a regional seminar on Working with NAVAREA II and your Primary Charting Authority (Data exchange).
- The objective of the seminar is to provide participants with an understanding of the way to work with NAVAREA II (Maritime Safety Information) and Primary Charting Authorities (Data exchange), risk assessment and survey specification.
- Accordingly, a two-day seminar will be held in Mindelo, Cabo Verde on 26-27 September May 2022. The seminar will precede the EAtHC17 Conference.
- A provisional agenda for the Seminar on Working with NAVAREA II and your Primary Charting Authority (Data exchange)" is attached at **Annex C**.

b) Follow-on Meeting

Participants in the seminar are expected to remain in Mindelo on completion of the seminar and to attend the EAtHC 17 to consolidate the knowledge gained during the seminar and to experience how an IHO Regional Hydrographic Commission (RHC) functions in the regional delivery of hydrographic services. In addition, the combination of attendance at the seminar and attendance at the EAtHC meeting will provide an excellent opportunity to establish or strengthen existing professional networks.

c) Funding Arrangements

- The IHO Capacity Building Fund will pay for all breakfast, lunch, accommodation, and travel for the seminar meeting from the list below at the following paragraph. Note that only one person by country could have his travel and hotel funded by IHO.
- Please note too that no monetary allowances will be paid directly to participants. Any associated expenses beyond the breakfast, lunch, accommodation, and travel provided by the CB Fund, such as travel insurance, pocket money and taxes (like E.A.S.E.) must be covered by the candidate or the candidate's organisation.

d) Nominations and Eligibility Criteria

- States in the region outlined in list below are invited to consider nominating suitables national representatives who will benefit from the opportunity of attending the seminar and the subsequent EAtHC meeting.
- It is essential that nominees are employed by a national hydrographic office, a maritime authority or a related national agency in the nominating country and are in a position to influence the development of the national hydrographic infrastructure. In this respect, a

statement indicating the role of the nominee in the national hydrographic infrastructure is required as part of the application process.

- List of 21 states invited: Cameroon, Democratic Republic of the Congo, Ghana, Morocco, Nigeria, Benin, Cabo Verde, Congo, Côte d'Ivoire, Guinea, Guinea-Bissau, Mauritania, Senegal, Togo, Angola, Equatorial Guinea, Gabon, Gambia, Liberia, São Tome and Principe, Sierra Leone.
- Given the Seminar budget, the eligibility priorities are:
 - i. EAtHC member states and associate members
 - ii. EAtHC observers

e) Application Procedure

- For the Seminar, a specific application form will be sent directly to the countries wishing to be funded (according to financial possibilities and priorities set out above) by email.
- Answers would be send to Mr. Henri Dolou (henri.dolou@shom.fr) at your earliest convenience but no later than 30 June 2022.
- It is the responsibility of Participants to apply for a visa if required and E.A.S.E (Efficient, Automatic & Safe Entry).

5. Venue Information

4. Efficient, Automatic & Safe Entry (E.A.S.E.) Visa for Cape Verde

As of 1 January 2019, the government of the Republic of Cape Verde exempts citizens of 61 countries

from visa requirements for stays up to 90 days. An online declaration a few days before arrival is still

required via the E.A.S.E. form. Payment of an Airport Security Fee is required.

For a trip to Cape Verde, the E.A.S.E. online pre-registration is a mandatory step for international

travellers over two years old going to Cape Verde. The registration concerns all nationalities normally

exempted from visa for a certain duration of stay and allows to arrive in four international airports: Boa

Vista, Praia, Sal, São Vicente and to stay in Cape Verde for a maximum of 90 days.

The price of this document, which is often compared to an electronic visa (EASE) Cape Verde, is 59 € per

traveller, with the compulsory airport security tax included in the price of this EASE Cape Verde. We

advise you to apply at least five days before your arrival on the island. We will actually submit it just

before you enter Cape Verde.

After arrival in S. Vicente airport, the IMP-CV agent will receive/meet the national representatives of

each participant country and transfer them to the Hotel.
