### Dear Esteemed Colleagues,

#### **Seminar on Raising Awareness in Hydrography**

- 1. The 2025 Capacity Building Work Programme of the International Hydrographic Organization (IHO) provides support for a regional seminar on *Raising Awareness in Hydrography*. This Seminar will precede the annual MACHC Conference and will focus on the Seabed 2030 Initiative.
- 2. Accordingly, a seminar will be held at the Headquarters of the Directorate of Hydrography and Navigation (DHN) in Niterói, Rio de Janeiro, on the 8 December 2025. The seminar will precede the 26<sup>th</sup> Conference of the Meso American Caribbean Sea Hydrographic Commission (MACHC26) that will be held from 9 12 December 2025, at the same venue.
- 3. Outline details of the seminar are provided at **Annex A**. The Seminar is open to all but some limited funding to support attendance is available, details are in paragraph 6.

#### **Working Language**

4. All seminar presentations will be delivered in English.

#### **Follow-on Meeting**

5. Participants in the seminar are expected to remain in Brazil on completion of the seminar and to attend the MACHC26 Conference to consolidate the knowledge gained during the seminar and to experience how a Regional Hydrographic Commission (RHC) functions in the regional delivery of hydrographic services. In addition, the combination of

attendance at the seminar and attendance at the MACHC Conference will provide an excellent opportunity to establish or strengthen existing professional networks.

#### **Funding Arrangements**

- 6. The IHO Capacity Building Fund will pay for flights, accommodation and breakfast, for the seminar and the subsequent MACHC26 meeting for **ONE** participant per country from the distribution list below. If invited, countries have the ability to support any part of their nominated participants travel (for example, paying for airfare so that the IHO pays for the hotel or vice-versa) please indicate it in the response to this invitation.
- 7. **Please note** that no monetary allowances will be paid directly to participants. The IHO Capacity Building fund, and host nation, will cover the following expenses for individuals:
  - Flights
  - Accommodation with breakfast
  - Lunch (included in the conference costs)
- 8. Any additional expenses beyond the accommodation and travel provided by the CB Fund, such as travel insurance, pocket money, subsistence (including other meals beyond those hosted) and visa fees must be covered by the candidate or the candidate's organization.

#### **Nominations and Eligibility Criteria**

- 8. Coastal States in the MACHC region are invited to consider nominating **ONE** suitable national representative who will benefit from the opportunity of attending the seminar. The representative will also be expected to fully participate and contribute to the subsequent MACHC Conference.
- 9. It is essential that the nominees representing their nations are employed by a national Hydrographic Office, a Maritime Authority or a related national agency in the nominating country and are in a position to influence the development of the national hydrographic infrastructure. In this respect, a statement indicating the role of the nominee in the national hydrographic infrastructure is required as part of the application process. The strength of these statements will help determine which participants are selected.
- 10. Noting the budgetary limitations, priority for funding will be given to those nations who have not been previously represented.

#### **Application Procedure**

- 11. To apply to attend the seminar, the following documents are required:
  - Completed Excel Application Form (**Annex B**) including the statement referred to in paragraph 8 this will be used to determine the suitability of the candidate. **Please return this as an Excel spreadsheet document.**
  - A copy of the applicant's valid passport within at least 6 months of expiration.
- 12. Applications to attend the seminar and copy of passport should be sent by email to Ms Lucy Fieldhouse, (email address: <a href="mailto:lucy.fieldhouse@ukho.gov.uk">lucy.fieldhouse@ukho.gov.uk</a>) with copy to MACHC Secretary Ms Nancy Yang (<a href="mailto:nyang@mas.sr">nyang@mas.sr</a>), at your earliest convenience but **no later than 6**November 2025.

- 13. Please note it is the responsibility of the participants to acquire a Visa if required and to meet all other travel requirements (<u>Visa Requirements</u>). Details can be found in MACHC CL06/2025 and include:
  - Return or Onward Ticket (to demonstrate the intent to leave Brazil within the permitted timeframe)
  - Proof of Accommodation (Hotel reservation or a letter from a host confirming lodging);
  - Financial Means (evidence of sufficient funds to support the stay, such as bank statements, credit cards, or cash)
  - Vaccination Certificate if required
- 14.
