### IHO Strategic Plan 2021-2026

#### **Established Goals:**

Goal 1: Evolving the hydrographic support for safety and efficiency of maritime navigation, undergoing profound transformation

Goal 2: Increasing the use of hydrographic data for the benefit of society

Goal 3: Participating actively in international initiatives related to the knowledge and the sustainable use of the Ocean

## Background

- Current IHO Strategy is for the period of 2021-2026
- Assembly decision 8 e) tasked the Council for the development of a revised Strategic Plan
  - Delivery of update SP to be adopted at A-4 in 2026
  - Council empowered to establish a Working Group as appropriate
- Council 7 decision 38 established a correspondence group to prepare the next IHO Strategic Plan 2027-2032
  - Chair: JP (also VP of Council), with BR, DE, DK, FR, GB, HR, NO, NZ, SE and US

Highlighted Member States of the SPRWG are Member States of MACHC





## Key Issues Identified at Assembly 3

- Decision C7/36 acknowledged the current structure as relevant an Existing
  - SoN production, inc S-100 framework (priority focus area)
  - Wider use of maritime data (beyond SoN products)
  - Build awareness within other organizations regarding hydrographic services
- Development an implementation of the S-100 framework
- Alternative Funding
  - Increase Capacity Building and infrastructure investments (S-100 etc)





#### **Current Status**

- In November 2023, The SPRWG Chair (JP) reached out to the identified WG members, and the Group is officially moving forward.
- The Chair is drafting a propose three-year revision process that will identify the deliverables and timelines.
  - Draft process to be shared with WG by mid January 2024
  - Final Draft process to be proposed to Council 8 in October
- WG members expect routine VTC meetings for the next several years to progress the draft Strategic Plan, and will keep the MACHC region informed





# Role of Regional Commissions

- RHC's have an implementation role in the Current Strategic Plan through the framework (standards, coordination, CB and coms)
  - Have all Member States considered impacts of the existing SP on their operations?
  - Has the MACHC reviewed activities as a region, against the existing SP?
- RHC's will be strongly represented in the new Strategic Plan
- Feedback from RHC's is needed, both to the existing, and the future Strategic Plan
  - Can the MACHC identify what is working, and what could be improve?

#### Member States

- Review and consider how the existing SP has affected your operations
  - Identify what has helped, and what can be improve (MS perspective)
- Consider submitting views to the SPRWB Chair (JP)

#### MACHC

- Review and consider how the existing SP has affected the region
  - Identify what has helped, and what can be improved (regional perspective)
  - Consider standing up a short-term Project Team to review above.
- Consider submitting feedback to the SPRWG
