Marine Aids to Navigation are developed and harmonized through international cooperation and the provision of standards.

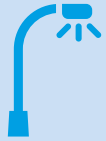
Goal 2

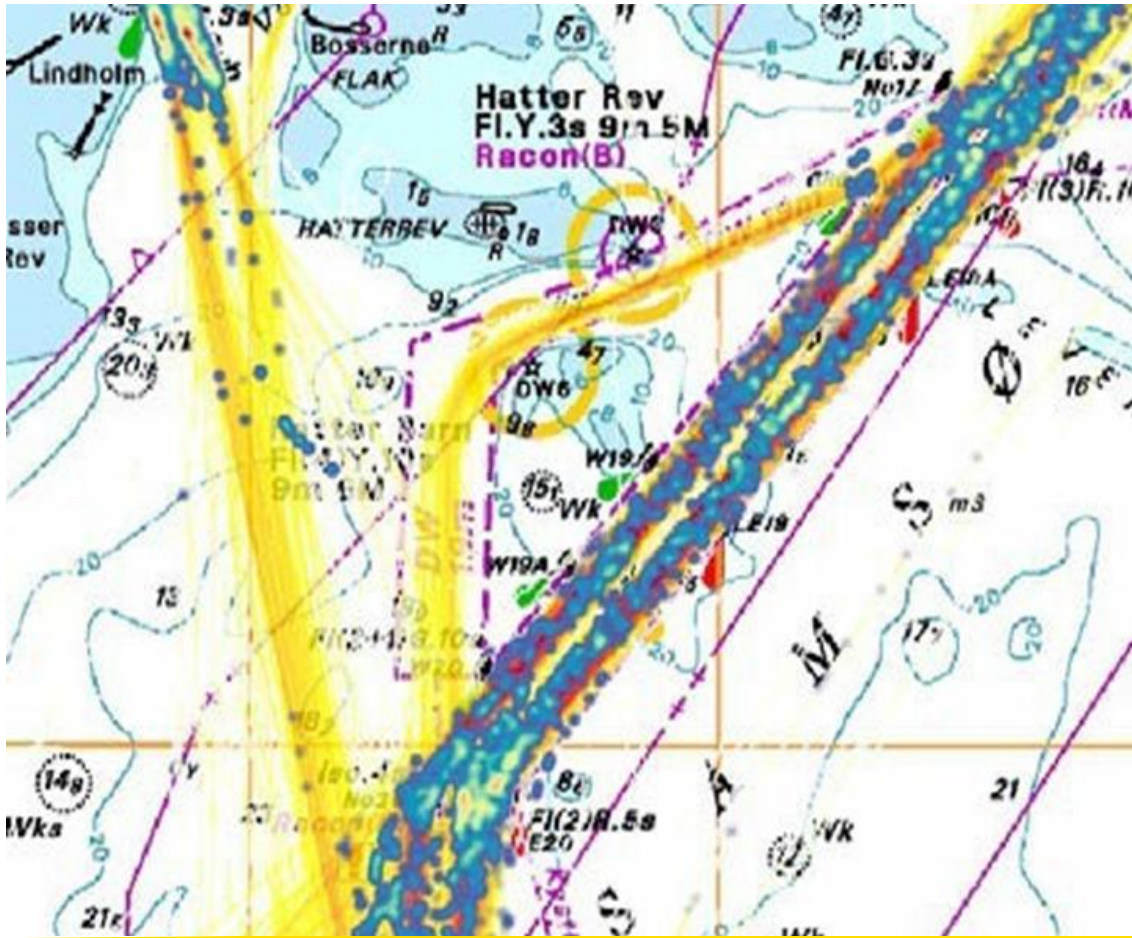

Capacity building



- Conducts workshops and seminars to raise the awareness of high-level decision makers with respect to their international obligations;
- Undertakes analytical missions to identify gaps between current practices and international standards and provides advice on how to bridge these gaps;
- Arranges follow-up activities to review progress made towards conformance with international standards; and
- Collaborates with sister organizations in capacity building activities

Solutions to theft and vandalism?

Recognize and respect fishermen, consider their needs. As an example; provide them with small yellow buoys to attach to their fishing nets, provide a mooring buoy

Technical solutions

AtoN Awareness with fishing communities, informing why the AtoN are important to fishing communities. As an example; tsunami warning equipment on buoys, AtoN can prevent ship accident and possible oil pollution of fish fields.

Adopt a “User Pays” system where the levies be imposed to all users , this could include, but not be limited to all shipping, being commercial, fishing and fishing related activities such as fish farms, pleasure and tourism. For fishermen ,to realize that the levies will increase if AtoN need to be replaced due to theft or vandalism, would hopefully result in a sense of ownership.
