Dear colleagues,

According to the actions of the 19<sup>th</sup> MBSHC (action MBSHC19/01) approved consequently to the 7<sup>th</sup> IRCC Conference (action IRCC7/07,) respectively in reference [a] and [b], the Chair was tasked by the Commission to ask the MBSHC members to provide with their estimated values of agreed Strategic Performance Indicators (SPIs) and Working Level Performance Indicators (WPIs) as of 31 December 2015 and target values for 31 December 2017, complemented by the comments on the difficulties encountered and suggestion for a way forward in order to provide the IRCC Chair with those values and remarks.

As a reminder, Performance Indicators (PIs) are part of IHO Strategic Plan (ref. [c]) which consists of vision, mission and objectives of the IHO. The SPIs are related to objectives of the IHO and WPIs are associated with the strategic directions of the IHO.

Besides, the indicators related to the cartographic and survey status of the MBSHC region will be provided as follows **not later than 30<sup>th</sup> of December 2015**:

- i. the percentage of available/agreed ENC schemes in MBSHC for 2015 and estimated values for 2017 (**SPI 8 & WPI 21**) will be provided by Region F ICC co-ordinator (FR),
- ii. the percentage of agreed INT chart schemes and available INT charts in MBSHC for 2015 and estimated values for 2017 (**SPI 8**) will be provided by Region F ICC co-ordinator (FR),
- iii. the status of hydrographic survey in MBSHC in KM2/NM2 for 2015 and estimated values for 2017 (**WPI 19**) will be provided by Spain (IHM).
