## Dear colleagues,

- In accordance with MBSHC Action from Reference A, the Hellenic Navy Hydrographic Service (HNHS) has resubmitted a proposal of INT chart scheme on the Aegean Sea for eight (8) international (INT) charts (No 3720, 3722, 3724, 3726, 3728, 3732 and 3738), attached in Annex A. In accordance with Reference A as well, this proposal is now submitted to the MBSHC for approval.
- 2. By decision of the MBSHC Chair and, in accordance with Art. 4a of the Statutes of MBSHC, this proposal is submitted following a voting procedure. The voting will be carried out as a secret ballot. **Member States are invited to review** the Proposal by Greece and to use the voting form provided in Annex B. Voting forms are to be sent via e-mail to the IHO Sectretariat (e-mail: <a href="mailto:yves.guillam@iho.int">yves.guillam@iho.int</a>), no later than 05 December 2022.
- 3. The outcome of the voting procedure shall be considered with the minimum number of 7 affirmative votes (at least one-third (1/3) of all Member States in accordance with Art. 4b of the Statutes of MBSHC).

Dear Madam Chair,

Following Action M8SHC23/17<sup>1</sup> of Ref b, the Hellenic Navy Hydrographic Service (HNHS) herewith resubmits the Ref a proposal for eight (8) international (INT) charts (No 3720, 3722, 3724, 3726, 3728, 3732, 3734 and 3738 as depicted in Annex A), in order for them to be included into the INToGIS database. Charts' metadata are shown in Annex B.

The production of the aforementioned INT charts, is in line with mariners' need for intermediate scale chart coverage across the Aegean Sea, given the shipping density over this area. These charts cover the needs of international navigation in the Aegean Sea and have been considered relevant by the Regional Charting Coordinator. They were also properly circulated by the latter with a recommendation to be included in the Region F INT scheme (Region F ICCWG CL 02/2019 as attached), given that no valid technical arguments were presented to the contrary.

In this respect, you are kindly asked to forward our proposal to the MBSHC for approval and inclusion into the INToGIS database.

I kindly ask for your prompt sequential actions on this issue, which will contribute to the safety of international navigation.


