#### **LIST OF MBSHC23 DECISIONS**

Decision Nº	Decision
MBSHC 23/01	Noting the situation in the Black and Azov Seas at the date of the MBSHC23 (March 2022), the MBHSC agreed to carefully monitor the situation in that part of the Region (MSI, disaster response, charting), in order to provide any potential contribution to maintain the safety of navigation and to safeguard the protection of environment in the area.
MBSHC 23/02	MBSHC approved the revised Statutes of MBSHC as proposed in Annex I of the MBSHC CL 02/2022 and agreed that they will come into force from 1 April 2022, at the close of the MBSHC23.
MBSHC 23/03	MBSHC approved the Disaster Response Framework (DRF).
MBSHC 23/04	MBSHC will continue through the ICC WG the revision of the ToR and RoP of Region F ICCWG, starting from the current version in force (6 July 2017) and provided guidance to the ICC WG to incorporate into the scope, governance for coordination of S-101 production and to propose options to MBSHC.
MBSHC 23/05	MBSHC approved the list of changes to INT paper charts scheme proposed by the acting Region F ICC WG coordinator for urgent matters given in the specific annex to this document.
MBSHC 23/06	MBSHC approved the re-establishment of the Region F database in the Aegean sea in INToGIS, as it was on 14 February 2022 (cancellation of the "blanking" reported in the IHO Secretariat Letter S3/0113 dated 10 February 2022).
MBSHC 23/07	The MBSHC approved the designation of Greece as Region F IRCC Coordinator and Turkey as Vice-Coordinator until MBSHC24 included. The MBSHC also agreed on the rotation on these positions after MBSHC24 and until MBSHC25, with Turkey becoming Region F Coordinator and Greece Vice-Coordinator.
MBSHC 23/08	MBSHC agreed to create the MBSHC-S-1XXWG .
MBSHC23/09	The MBSHC Vice Chair designation process will be open by CL in the following weeks.

#### MBSHC23/10

In the CL (call for Vice-chairpersonship), the MBSHC Chair will also ask for candidatures to host the next Conference in 2024 in accordance with Art. 5.b/ and 7.h/ of the new Statutes. For budget and planning reasons, decision on host country, dates and venue to be made no later than June 2023 (or A-3 in April 2023 so decision can be announced).
