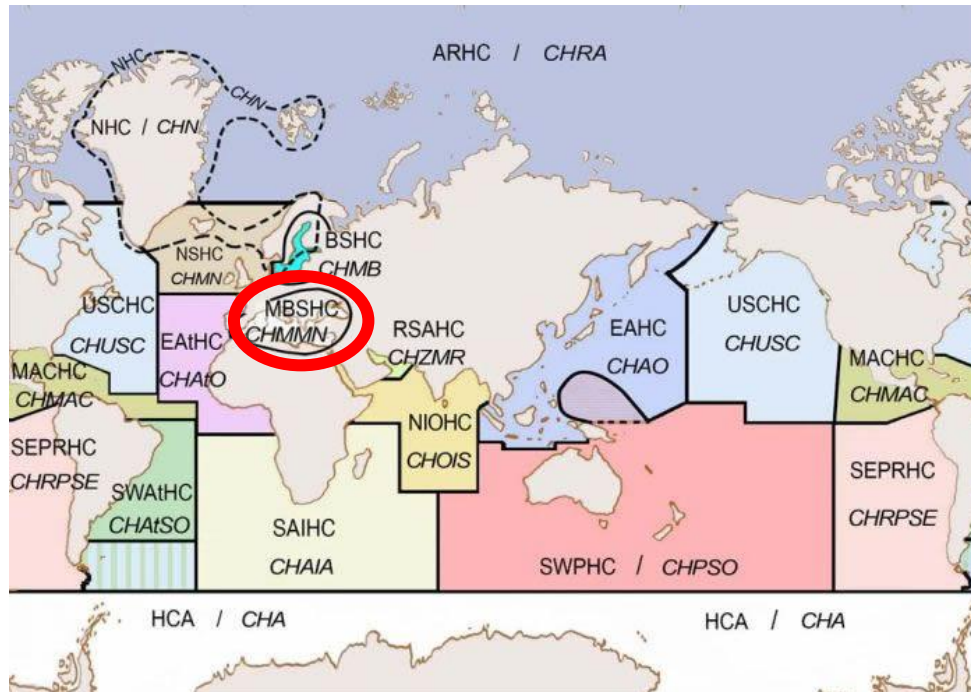

Greece received mandate from MBSHC 23 (Decision 23/07) to resume the duty of Region FICC Coordinator until MBSHC24.

Greece dealt with 4 proposals and 1 revision of the group ToR and RoP up to now. Additionally three CLs were sent regarding S-101 products, list of ports in the region and ENC overlapping comments reporting.

The 4 proposals concern INT charts of Egypt, Lebanon, Greece and ENC coverage of UK south east of Cyprus, while the Revision of ToR and RoP lies under the MBSHC 23 Decision 23/04.

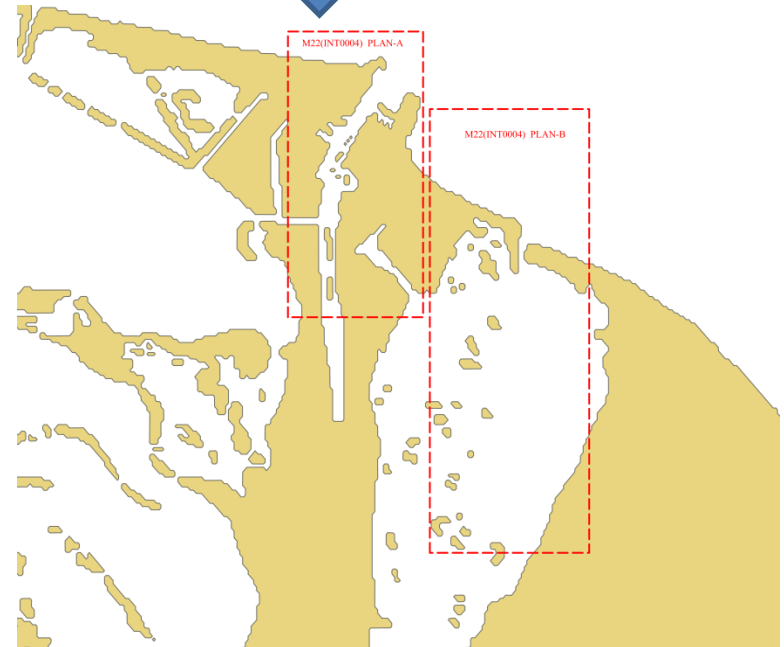

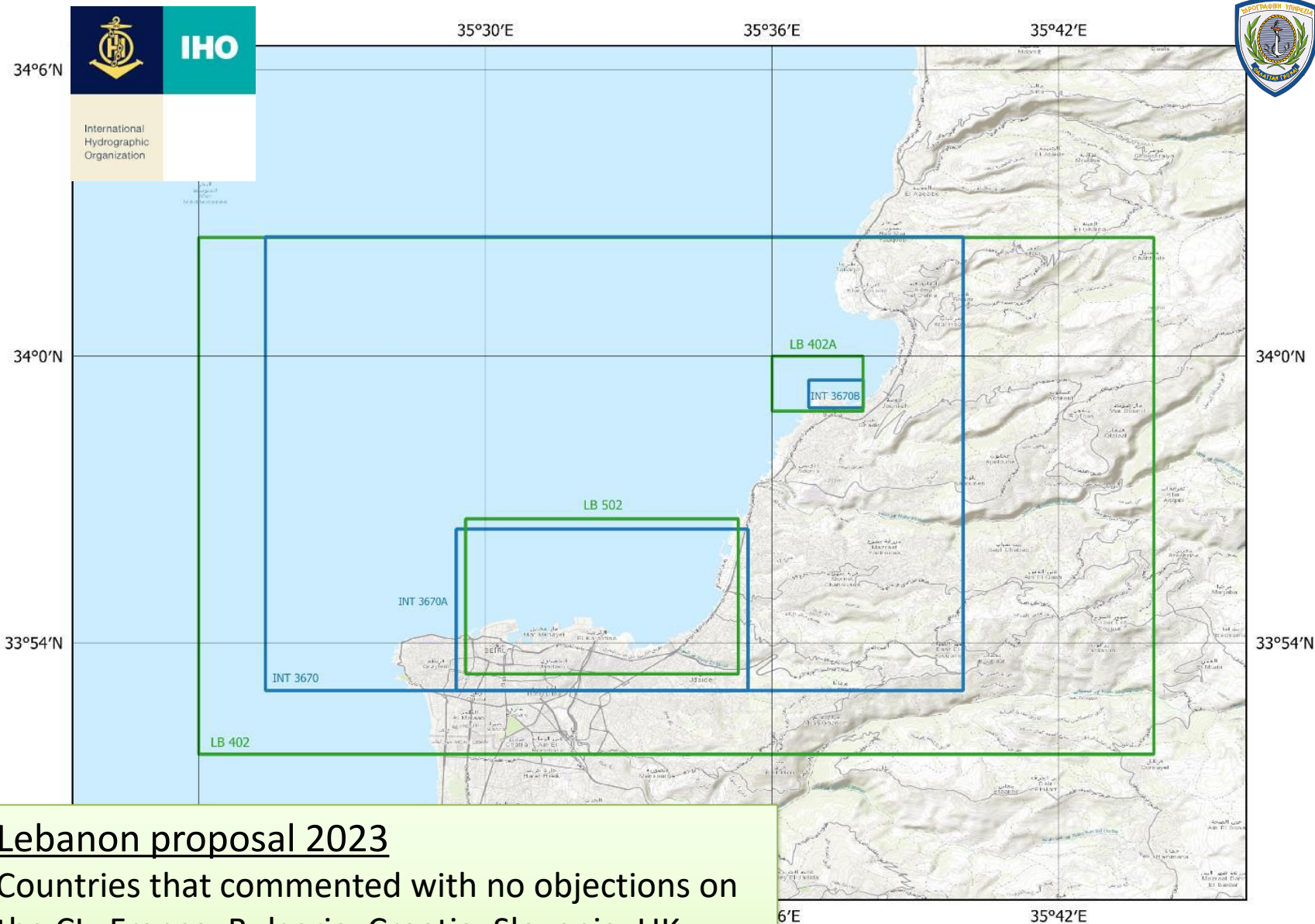

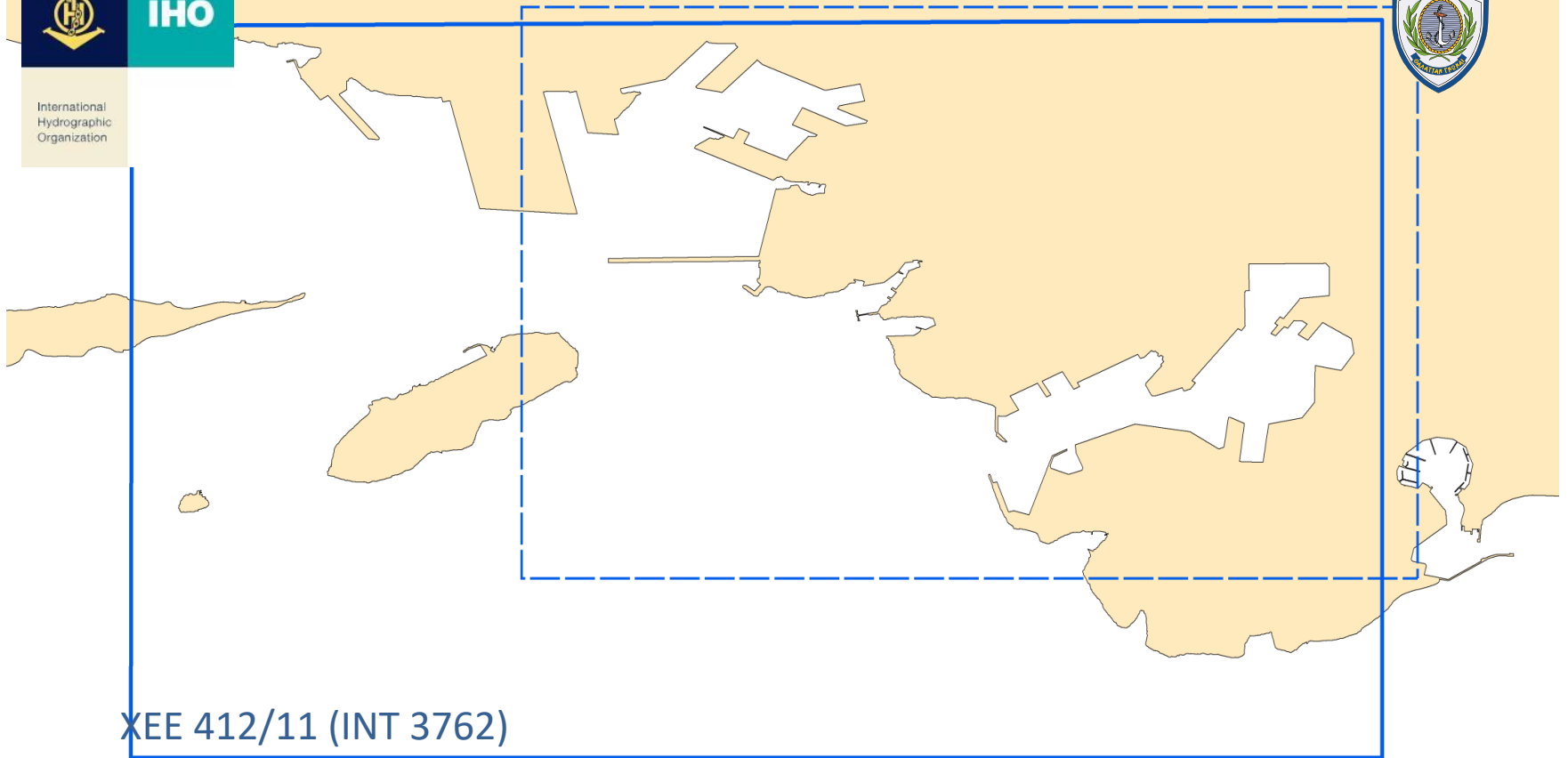

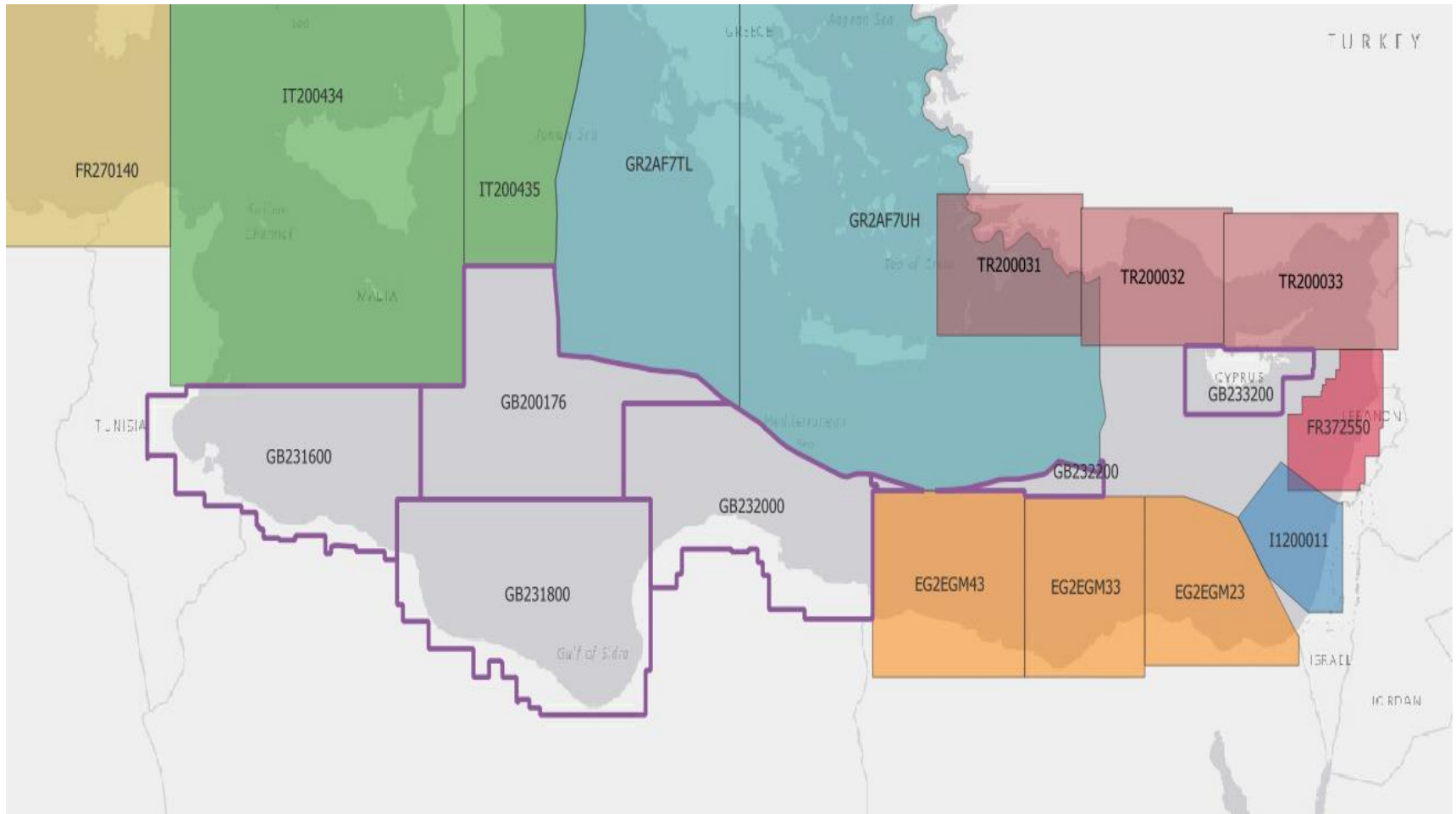

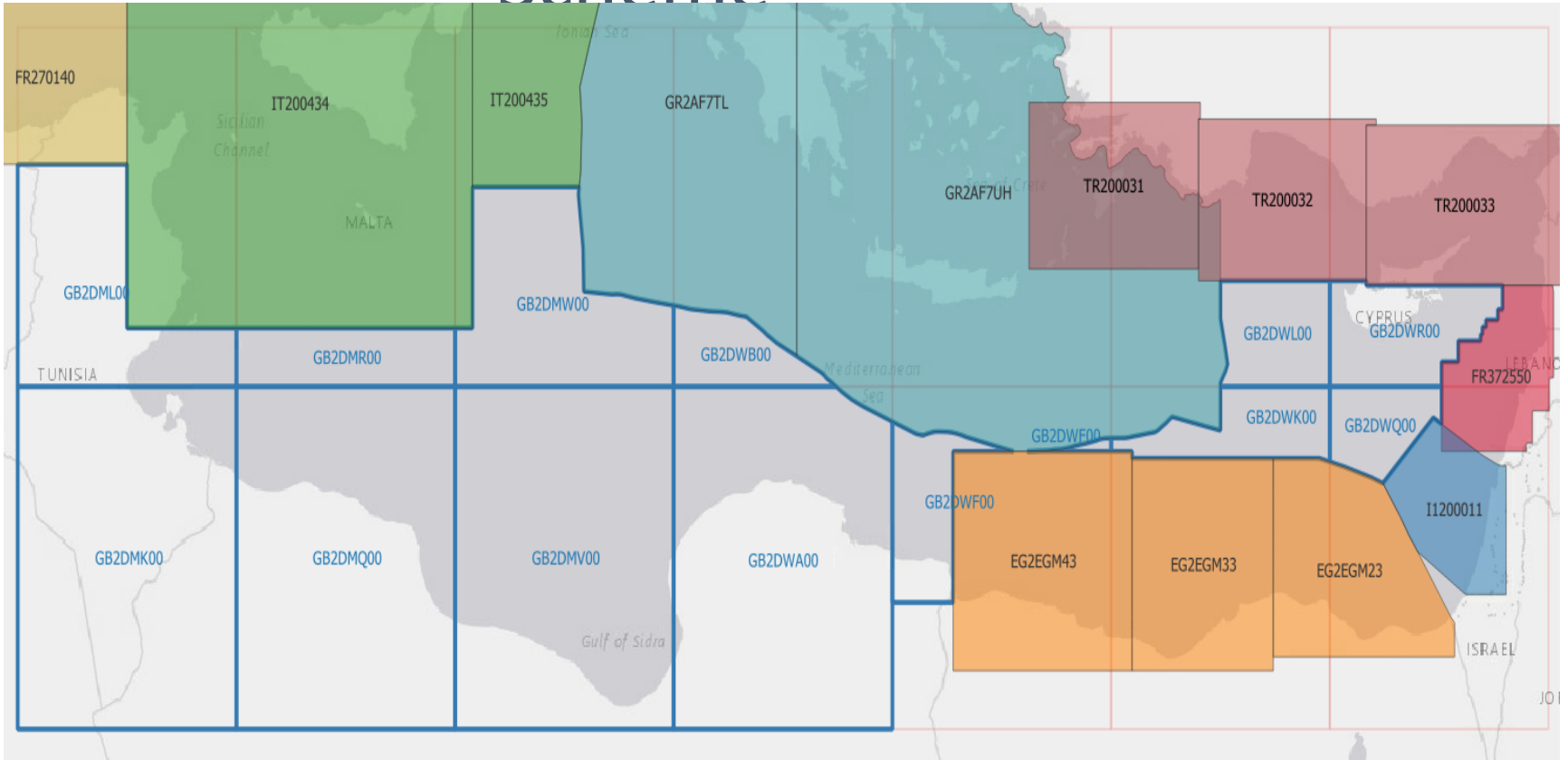

Existing Scheme



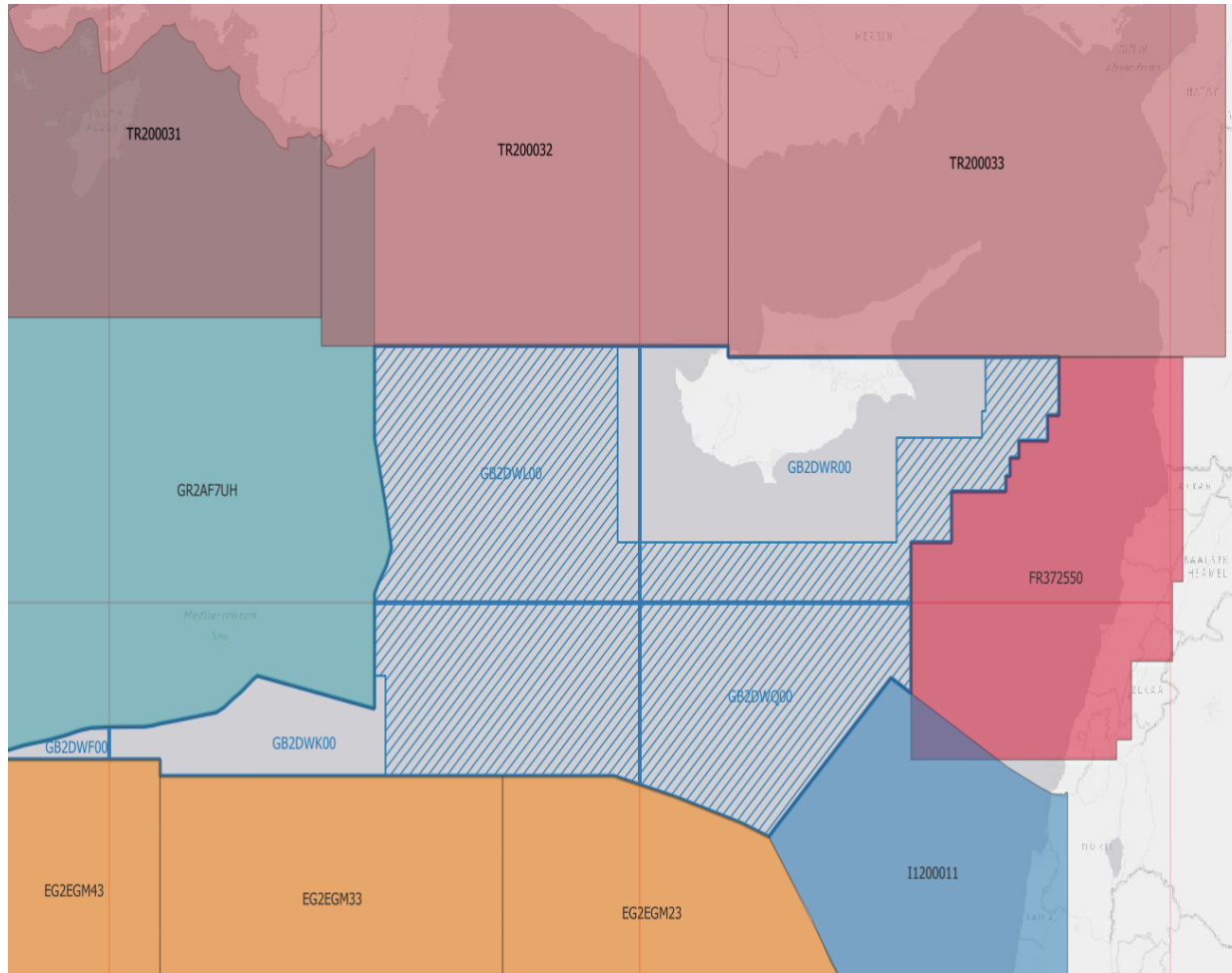


Proposed Gridded Scheme

FICCWG Coordinator invitation for ToR and RoP revision under MBSHC 23/04 Decision

- FICCWG CL 04-22 the procedure was initiated. Spain, France, Greece and Croatia commented.
- FICCWG CL 07-23 First draft was circulated with received comments incorporated. Croatia ,Turkiye, UK and France commented.
- A second draft has been circulated via CL 08/2024 for additional comments. FICC Coordinator received comments from Turkiye and Croatia while France, Cyprus and Italy informed the FICC Coordinator that they do not have any comments on the revision of ToR and RoP.



FICCWG Coordinator S-101

On 05 March 2024 FICC Coordinator sent the CL 04/2024 regarding a survey on S-101 products and data services. The survey comprised of three questions:

- Do you plan to provide the first products in 2026?
- When do you plan to provide the first products?
- Have you validated your products, through RENCs or other agents?

We have received feedback from eight Member states of the region.

MBSHC Permanent Action 11 (List of Ports)

According to respective communication with MBSHC Chair, FICC Coordinator has sent CL 05/2024 on 08 March 2024 where it is requested update of the list of ports of the region and complementary information.

To this extend we have received feedback from nine Member States of the region. With CL 09/2024 FICC Coordinator has informed Member States that an incorporated list of ports is being forwarded to MBSHC Chair.



FICC Coordinator ENC overlapping information depository.

FICC Coordinator had fruitful cooperation with MBSHC Chair on ENC overlapping. It was recommended by MBSHC Chair that FICC Coordinator will send a circular letter with reference to MBSHC Permanent Action no. 9 and no. 14.

FICC CL 06/2024 was released. It was requested from Member States to provide FICC Coordinator with the overlap information and comments on the associated risk assessment for each case of overlap using the (IC-ENC) RENC Report Template.

Seven Member States responded to the CL enabling FICC Coordinator to form a respective depository of overlap cases that will be given to the successive FICC Coordinator, Turkiye.
