Nordic Chart Production Expert Group, NCPEG Report

Introduction/Background

The purpose of NCPEG were evaluated in front of NHC-66 (2023). The discussion, in VTC meetings, covered how efficient and what results can be expected from this EG/WG. As an outcome NHC-66 agreed upon updated ToRs with a changed approach to focus more on appointed subjects. Previously NCPEG meetings have focused more on changing experiences with ad hoc reporting from respective MS. The new ToRs also included a permanent Chair.

Changes/improvements

To ensure even more efficient meetings with beneficial outcomes for every MS we have decided to really focus in few topics. Then we can work more in "workshop mode" at meetings to also focus on results as well as knowledge exchange. We will use the same MS reports as NHC as input papers to the meeting. Each MS will only report on dedicated topics at the meeting.

Report of Actions completed

- NCPEG have elected Thomas Gränne, Sweden as Chair in October 2023. Election held by NHC Chair Magnus Wallhagen by correspondence.
- Established new/updated contacts from some MS.
- Arranged a VTC planning meeting in February 2024, in front of the physical NCPEG meeting in May. At the planning meeting NCPEG established topics and plan for NCPEG meetings.
