- 2/2018 : Bathymetry Contours Workshop to share knowledge and experiences of Contouring algorithms Germany 34th NSHC
  - ➔ Workshop on 'Bathymetric data processing for nautical products' was organized by in Hamburg Bundesamt für Seeschifffahrt und Hydrographie (BSH) from 9 till 11 April 2019
- 1/2018 Crowd sourced data RWG to investigate how crowd sourced bathymetry can support the work of the NSHC RWG 34th NSHC Open
  - ➔ Paper RWG
- 6/2016 B.5: Vertical reference (LAT) comparison; Continue to investigate and reduce the differences between the LAT along boundaries in accordance with the action items of TWG WP 18/1. Publication of those differences is paused until the outcomes of the investigations are available
  - ➔ Investigation of differences was concluded. The smaller than 1% water depth acceptable differences were not achieved in very shallow water along national boundaries.  
  
DNLHO (2020) en DEHO (2021) have published updated versions of their LAT reduction models. BEHO is in the process of developing an updated version (2022?). Differences along national boundaries continue to require attention.

- 3/2010 (Concl. 89) NSHC Resurvey WG NSHC decided to task the NSHC resurvey WG:
  - ➔ to complete the overview where applicable: available on nshc.pro (2 versions: cartography based on CATZOC and RWG standardised 5 resurvey intervals)
  - ➔ to publish the scheme on the internet: available on nshc.pro
  - ➔ to propose a way forward to harmonize the presentations of the resurvey schemes and of C55: Harmonization of resurvey schemes/intervals is done. Input was provided for the C55.
  - ➔ to include conclusion 28 “Resurveying of critical areas” in their work program: completed.
- 6/2014 (Concl. 112) Risk assessment : undertake a risk assessment analysis for the North Sea area, including the Dover Strait
  - ➔ RWG decided not to make a RAA for the DSSS. Nevertheless there have been recent national initiatives in this regard (incl. NLHO), results of which could possibly also be expanded for the NSHC area. There are currently no agreements on this.
