 - d. How do we collectively meet the challenges and achieve the goals and targets of the strategic plan?

Please complete the analysis in the template provided and send to SWPHC@linz.govt.nz by 5 February 2021. Do not hesitate to contact me if you require further guidance or you may seek assistance direct from your Primary Charting Authority.
