<b>Review and agreement of minutes and actions arising</b>	<p>HP opened the meeting, and all joined in welcoming new member Amy Nau from Commonwealth Scientific and Industrial Research Organisation (CSIRO).</p> <p>Minutes from the 9<sup>th</sup> meeting of the SWPHC MSDI WG accepted as true and correct.</p> <p>Actions were reviewed, updated, and closed accordingly. The following noteworthy actions received attention:</p> <ul style="list-style-type: none"> <li>• To investigate local policies wrt indigenous data governance and sovereignty. BP asked whether RG could give an update on the meeting between New Zealand government and indigenous representatives. Could Rachel share her experience of this meeting?</li> <li>• WG to share Open Data Policies – Reminded members to look at any open data policies that are possible to share.</li> </ul>
<b>Request from Andy Cootes at World Bank to use</b>	<p>HP gave update on request from Andy Cootes to use Data Value Proposition in use case inventory that the World Bank is producing and will be publishing. HP</p>

<p><b>Data Value Proposition in use case inventory</b></p>	<p>and BP suggest we accept this offer but ask that the SWPHC MSDI WG is cited in any publication.</p> <p>Members discussed benefits of sharing the data value proposition to gain wider audience and awareness of document.</p> <p><b>DECISION:</b> Working Group members agreed to allow DVP to be used in Andy's World Bank publication, with caveat that Working Group is cited.</p> <p>HP to contact Andy to let him know the members approve the use of the DVP in his paper.</p>														
<p><b>Data Value Proposition Communications Plan</b></p>	<p>BJ shared a draft communication plan and led discussion on how the group wants to share and promote the Data Value Proposition. Discussion focussed on the stakeholders we want to reach.</p> <p>Do we want to reach only Hydrographic Offices, or the SW Pacific Community or do we want to reach a wider audience. Some potential activities discussed:</p> <p><b>ACTION:</b> All - Look at other ways to add to the communication plan to promote the Data Value Proposition in our different activities and areas of influence.</p> <p><b>Distribute at regional meetings and conferences</b></p> <p>BJ – Offered to display some copies at the GEBCO stand in the industry exhibition at IHO Assembly in Monaco.</p> <p>SK – Offered to display some copies at the SPC stand at the Heads of Transport and Energy Ministers Meeting in Vanuatu.</p> <p><b>LinkedIn Post</b></p> <p>WG discussed benefits of creating a MSDI WG LinkedIn account or utilising existing accounts from SWPHC or other organisations. There is no group account for SWPHC at present but was discussed at SWPHC20 so may be created in future.</p> <p>BP – Managing a group account is a big undertaking for individuals from the WG.
