Review and agreement of minutes and actions arising	HP opened the meeting. Minutes from the $17^{\rm th}$ meeting of the SWPHC MSDI WG accepted as true and correct.
Feedback from SWPHC Work Plan Meetings	HP and BJ were unable to attend the last work plan meetings, but goals and activities were submitted to the SWPHC work plan meeting and have been accepted into the SWPHC work plan. SC attended the work plan meeting and provided some feedback on discussions. Work plan activities have been collated and will be finalised and shared with members in due course.
Discuss and Prioritise work plan for coming year.	HP reviewed goals and activities that were agreed at the 17 th SWPHC MSDI WG meeting. HP asked the members for thoughts on which activities could/should be prioritised first.

General discussion points:

AM suggested that the WG investigate and define the resource required for each activity, were there any activities that could be done easily/quickly and others that required longer term investment?

SC added that there may be opportunities to collaborate with other group in the region on activities that are already in progress.

The following discussion points were raised, linked to specific goals/activities:

Goal 1 - To work in the "Pacific Way"

Discussion between WG members about the intention of this goal, working in the "Pacific Way" is influenced by culture, family, faith and beliefs having a higher priority than capital gain, among other considerations and can have both positive and negative connotations. This goal is intended to ensure that, as a working group and Regional Hydrographic Commission, we are engaging and working in a way that works best for our members.

This can be done through a number of activities, such as engaging with other working groups in the region and aligning our terms of reference where appropriate.

A definition of what "The Pacific Way" means, for those from outside the region, would be beneficial to improve engagement between all partners, however, this definition would be best developed by people from within the region.

AL commented that SPC are trying to achieve this with other working groups in the region to set up a baseline using UNGGIM IGIF framework so that differences in culture can be understood by all parties to achieve the beneficial outcomes for the region.

General agreement that Activity 1.1 requires more effort to align with other working groups and communities to ensure we are working alongside working groups in the region before amending terms of reference or trying to define what "Working in the Pacific Way" means.

Certain tasks relating to activities 1.1 and 1.3 could be started in the shorter term, aiming to work towards activity 1.2 to update the Terms of Reference in due course when the goal is understood more fully.

Goal 2 – Members understand and know how to use IGIF to best support their needs in an applicable way.

Activity 2.1 to promote the work already completed and gather feedback could be progressed at other workshops and conferences in the region.

The working group has members that attend events such as the Seabed 2030 Pacific Mapping Meeting in Fiji in November and the corresponding IGIF workshop being held alongside. Both BJ and AL are likely to be attending these events in Fiji and it could be an opportunity to share the work done by the SWPHC MSDI WG.

HP asked whether group could start putting resources together that could be presented to upcoming event and identify members who may be attending these events.

Events include:

- Seabed2030 in Fiji (November)
- Joining Land and Sea workshop in Indonesia (December)

TEMPORARY ACTION – Create list of upcoming events and contact organising committee for particular events and whether they are hybrid or in person. We can target particular events and develop resources. DM and HP will create list of upcoming engagements and circulate with members to identify attendees or hybrid options.

Objective to link up with groups, and identify opportunities to align with other organisations.

DC suggested that a list of organisations or groups that we aim to engage with would also be useful to record.

Activity 2.2 – Gather feedback on the value and need for implementation and adoption of IGIF.

HP asked for thoughts on how we may approach this activity, concern raised in previous meetings about being too prescriptive on whether countries should adopt and implement IGIF. Maybe some work needs to be done to identify the need or ambition of nations to adopt IGIF.

SC/AL suggested Fiji, Tonga, Kiribati are actively looking at IGIF action plan. Tuvalu, Vanuatu and Papua New Guinea have raised interest in IGIF adoption.

SC suggested it may be a potential session at the next SWPHC to gather feedback from these countries already looking at IGIF to identify what they have done to be able to progress their activity and what they are hoping to achieve from investigating IGIF adoption.

HP suggested that we make contact with those countries who are investigating IGIF adoption. AL agreed to draft email that could be sent to members from those countries. AL asked DC to support.

TEMPORARY ACTION – AL to develop draft email that can be used to contact delegates from countries working on IGIF adoption.

Feedback from Marine Geospatial Working Group meeting in July

HP asked whether any working group members attended the MGI Working Group in July.

AL highlighted that a presentation from the Singapore delegation showed that there is work ongoing to connect land and sea. AL will share presentation to WG members. Also presentations from Fiji and Tonga that may be of relevance to members.

Singapore (Maritime Port Authority and Land Authority) is investigating partnering opportunities for joining land and sea initiative.
