### 4. Problems Encountered

- Travel restrictions imposed by governments as a result of the COVID-19 pandemic has postponed a number of capacity building activities. This is likely to continue into 2022.
- Large geographical extent of SWPHC region
- Cost of travel is high, opportunities for meetings limited.
- Capacity of the Capacity Builders.
  - More, potentially too much, is being asked of the RHC Office holders; which then impacts delivery of their own HO and RHC based activities
- Engagement of coastal states
  - Coastal states are presented with numerous CB and development activities and programmes which can impact their ability to be able to engage meaningfully.
- Awareness, coordination and collaboration between CB/development activities in the region
  - Numerous CB and development activities/programmes are being planned or delivered in the region at any one time.

• SWPHC18 meeting included a session on the IHO Revised Strategic Plan, Agenda Item 12.

Coastal States provided a high-level gap analysis for each goal of the Strategic Plan, answering the questions:

- Where are we now?
- What is the gap?
- What is the role of the SWPHC to meet the goals/targets of the strategic plan?
- How do we collectively meet the challenges and achieve the goals and targets of the strategic plan?

A summary of the gap analysis was provided by France (Goal 1), US (Goal 2) and UK (Goal 3). The SWPHC CB Coordinator and Australia summarised the actions identified to develop a SWPHC Work Plan and a Working Group is to be formally established to review the actions

(SWPHC18 Action 18). All documents are available on the SWPHC18 webpage (<u>https://iho.int/en/swphc18-2021</u>).

- In response to IRCC12 Action 12, SWPHC18 meeting included a session on GEBCO and Seabed 2030, Agenda Item 14. Actions include a request to SWPHC Members to complete the Seabed 2030 Community Survey; provide images to the Seabed 2030 Image Stream; provide bathymetric data to the Seabed 2030 Project using the Contributing data form; and for IHO Members and non-Members to review their policy on data release and consider submitting positive responses to CL 21/2020 or IRCC CL 01/2020 (CSB Data for Public Domain).
- The first meeting of the SWPHC MSDIWG was held 3 February 2021. Further details are available on the SWPHC MSDIWG webpage (<u>https://iho.int/en/msdiwg-0</u>).

# 6. Conclusions and Recommended Actions

Although the COVID-19 pandemic has impacted in-person activities, work continues in the virtual space. This was evident with the successful delivery of the SWPHC18 VTC meeting, and in particular, the session on the IHO Revised Strategic Plan to assist in formulating a SWPHC 3-6year Work Plan.

Discussions on the Strategic Plan raised the following:

- further work is required on the Strategic Plan Indicators (SPIs).
- IRCC and Council to consider the need for region specific SPIs.
- there is a need for ongoing regional sharing and communications regarding the transition to S-1xx products and services.
- with respects to Goal 2, Council to consider the consolidation of a single data portal as a single point of truth, rather than each Member developing their own portal.
- the need to further discuss a maturity model for MSDI.

SWPHC, in collaboration with other international, regional and bi-lateral partners, is committed to carrying forward hydrographic, nautical cartographic and capacity building activities in close alignment with IHO objectives and goals.
