2. Summary of appreciation for IRCC report and items related to WENDWG in particular by HSSC

I provided the IRCC report to HSSC 16, highlighting the good relationship between the two committees; see

HSSC 16 took note of the various IRCC activities and assigned actions to their subordinate bodies if deemed necessary.

The committee agreed on the WENDWG proposal to separate the *Guidelines for the Coordination and Management of the Development of S-100 Electronic Navigational Data Services (except S-101 ENCs)* from other S-11 content and to develop a new Part C.

HSSC 16 endorsed the following recommendations from the WENDWG in particular, if and when approved by the IRCC:

- the importance to prepare an input covering S-100 data services and the global approach (S-101+ Phase I S-1xx) for updating the S-100 Roadmap (IRCC slide 12/25).
- the recommendation for the implementation of a cyber-secure pull-mode from different sources of information using the SECOM interface (IEC 63173-2) on the Maritime Connectivity Platform (IRCC slide 13/25, while noting that this issue goes beyond the simple remit of the IHO)
- the necessity to put more active effort on the S-100 communication strategy towards stakeholders (IRCC slide 10/25) from now.

IRCC 16 approved the WENDWG recommendations.

3. Summary of work items assigned to WENDWG by IRCC

I delivered the WENDWG report to IRCC 16, see

The committee noted the achievements of our last WENDWG meeting and the work done between WENDWG 14 and IRCC 16.

4. Invitation to contribute to the S-11 Part C drafting work

Both committees endorsed the WENDWG proposal to develop a new part C of the S-11 Standard.

We had the first session on the potential table of content during our WENDWG 14 meeting. The small task group (AU, BR, DE, FI, GR, TR, IHO Secretariat) developed the initial ideas further and we provided the first full table of content (ToC) to IRCC 16. IRCC 16 tasked us to continue the ToC development and to draft content with the completion target line by IRCC 17.

As discussed at WENDWG 14, the development of Part C content will be an iterative process. I suggest starting with the *GENERAL GUIDANCE FOR ELECTRONIC NAVIGATIONAL DATA SERVICES PROVISION* and in parallel with the GUIDANCE FOR S-102 (BATHYMETRIC SURFACE) DATA PROVISION. The work on S-104 and S-111 will commence afterwards taking into consideration feedback on S-102 guidance development.

The draft ToC is attached to this document as a separate file S-11 PART C development Version 0.0.1.docx

I would like to invite **all WENDWG members** to **consider participation** in the drafting work **by the 30 July 2024**. It would be very much appreciated if you could indicate to which part of the two sections you would like to contribute. My plan is to collect and incorporate all contributions. A new version of the document will be provided to all as soon as I have received new content.

5. Plan for further surveys

The INToGIS III development is making significant progress and commissioning is scheduled for Q4/2024. Therefore, I hope that the 2025 survey and the Strategic Performance Indicator (SPI) determination will be managed by assessing INToGIS III data.

We agreed at the WENDWG 4 meeting that we can potentially use survey data collected by the RENCs this year and that we might only address those ENC producing HOs that are not Members of RENCs or that did not submit their data to the RENCs. We will do it in the same ways as we did last year, the submissions will be used for statistical assessments only and will be kept strictly confidential. A separate WENDWG letter in this regard will be issued in September this year.

6. Work items from IRCC 16

IRCC 16 assigned three work items to WENDWG.

Action item 3 is related to the RHC representatives to develop their schedule to meet the 2026 IMO target (S-100 ECDIS) and to report this to the next WENDWG meeting. This is an action item with due date WENDWG 15 submission deadline 10 January 2025.

Action item 4 is on the S-11 Part C development and was discussed under point 4 in detail.

Action item 5 focuses on a better description of the term ENDS. I plan to discuss this topic at the WENDWG 15 meeting.

In conclusion, this WENDWG Letter 1/2024 contains two primary action items with respective due dates:

1. **all WENDWG members**; to consider participation in the C11, Part C development drafting work and respond to the WENDWG Chair **by the 30 July 2024**.

2. **RHC representatives**, to develop schedules to meet the 2026 IMO target (S-100 ECDIS). by **10 January 2025**.

7. Date and location of WENDWG 15

Considering that most of you are preparing the 2025 budget, I also take this opportunity to confirm that the next meeting will be in the Australia (Wollongong) from 18 to 20 February 2025, as a face-to-face event for 3 full days. The WENDWG thanks Australia for their generous offer.

It would be absolutely beneficial for the host if you **indicate participation** as soon as possible and **by the end of August 2024** at the latest. It is enough if you send me an email indicating the number of persons your organisation plan to send to the meeting. This indication doesn't replace the official meeting registration procedure. It is simply a courtesy for Australia as the host country.
