Complete review and amendment of NAVTEX Manual, MSC.1/Circ.1403/Rev.228 November 2022, including harmonization with IMO resolutions A.705(17), A.706(17), A.1051(27) (IMO/WMO Worldwide Met-Ocean Information and Warning Service – Guidance Document), and the Joint IMO/IHO/WMO Manual on Maritime Safety Information (MSI).
6. Review the NAVAREA Self Assessment pro forma content and guidance. Review the accuracy of the IHO WWNWS coastal state countries found in the in the C-55 GIS project—source file will be accessible via the IHO WWNWS DRWG23
 - a. Please note that the Self Assessment data usage section for Inmarsat, Iridium, and NAVTEX data usage will be discontinued on the WWNWS17 Self Assessment.
