

Broadcast Times: 1000 UTC and 2200 UTC daily



NAVAREA IV/XII achieved a significant milestone implementing Iridium SafetyCast this past year. After training and testing NAVAREA IV/XII commenced an "under trial status on 14 DEC 2020. After a successful trial period, NAVAREA IV/XII commenced its "operational" status on 24 MAR 2021. We are broadcasting Iridium SafetyCast coastal warnings on behalf of NAVAREA IV coastal areas A and C, French Antilles and French Guyana.

There are 20 Coastal Warning stations within NAVAREA IV, 18 NAVTEX stations and 2 International Enhanced Group Call Service stations.

There are 10 Coastal Warning stations within NAVAREA XII, all NAVTEX stations.

4. Operational Issues:

NAVAREA IV and XII:

U.S. Coast Guard Communications Command (USCOMMCOM) provided 259 MSI reports regarding changes to U.S. NAVTEX and Remote Communication Facilities operational status within NAVAREA IV and NAVAEA XII. These include both scheduled outages, unscheduled outages, and notices to cancel

navigational warnings. The Amphitrite Point NAVTEX station in Canada was off air for 679 hours from 09 October to 09 November 2020 due to the relocation of transmission facilities.

NAVAREA IV and XII were impacted by the COVID-19 pandemic in the spring and summer of 2020. In the fall and winter of 2020 NAVAREA IV and XII experienced an increase of MSI and that has continued into 2021. NAVAREA IV and XII are currently on track to promulgate a similar amount of Navigational Warnings in line with a pre-pandemic year.

Capacity Building:

The Dominican Republic and Panama have provided MSI reports to NAVAREA IV/XII on a regular basis in the past. However, in 2021 both Nations doubled their reports to the NAVAREA coordinator. The Dominican Republic hosted the IHO Capacity building course in December of 2019 and Panama last took the course in 2016. NAVAREA IV and XII greatly appreciates the Dominican Republic and Panama's contributions and their support to ensuring safe navigation.

In 2020, NAVAREA IV received MSI reports from 57% of national coordinators. NAVAREA XII received MSI reports from 38.8% of national coordinators. This constitutes 6% decrease in national coordinators sending MSI reports to either NAVAREA IV or XII. 31 of 42 (74%) national coordinators within NAVAREA IV have completed the IHO MSI capacity building course. 6 of 18 (33%) of national coordinators within NAVAREA XII have completed the IHO MSI capacity building course. Of the 37 national coordinators that have received MSI training only 22 have received training within the last 5 years.

Do you issue "In Force warnings" Bulletins?

Yes.

How do mariners find the text of your "In Force" warnings that are more than 42 days old and which are no longer broadcast?

In-Force NAVAREA IV and XII messages are posted each morning (to https://msi.nga.mil/NavWarnings) from the previous 24hrs. Active NAVAREA IV and XII messages can be queried by a variety of menu options to include by specific NAVAREA, by NAVAREA number, by a NAVAREA number range and by date and date range. Quick links to In-Force Navigational Warnings are issued daily including weekends and holidays.
