1. Background

1.1 The IHO has encouraged the establishment of Regional Hydrographic Commissions (RHCs) to coordinate hydrographic activity and cooperation at the regional level. The RHCs are made up of IHO Member States together with other regional States that wish to participate. RHCs work in close harmony with the IHO to help further its ideals and program. RHCs meet at regular intervals to discuss such things as mutual hydrographic and chart production problems, plan joint survey operations, and resolve schemes for medium and large-scale International Chart coverage in their regions.

2. Discussion

- 2.1 The mission of the IHO is to create a global environment in which States provide adequate, standardized and timely hydrographic data, products and services and ensure their widest possible use.
- 2.2 Hydrographic offices (HO) everywhere are facing significant and rapidly developing challenges. Some challenges impact the mission of the IHO and shape the context by which the Organization develops its strategy to fulfil its vision. To face these challenges, the IHO structured its <u>Strategic Plan for 2021-2026</u> into three overarching goals. Under the three goals, the Organization identified targets to be reached by 2026. The progress towards these targets is measured by strategic performance indicators (SPI).
- 2.3 The first strategic goal seems to align the most the WWNWS terms of reference. The first goal is to evolve the hydrographic support for safety and efficiency of maritime navigation, undergoing profound transformation. Further, the IHO associated this goal with its mission objective to improve global coverage, availability and quality of hydrographic data, information, products and services and to facilitate access to those.

- 2.4 To achieve the IHO's three Goals, the IHO Secretariat and the two IHO Committees the Hydrographic Services and Standards Committee (HSSC) and the Inter-Regional Coordination Committee (IRCC) will deliver and pursue the respective Work programmes, using the following means:
 - Standardization
 - Coordination & Cooperation
 - Capacity Building
 - Communication.
- 2.5 One effective method to support the IHO's Strategic Plan and its Phase 1 capacity building objective (Phase 1: the collection and circulation of nautical information, necessary to maintain existing charts and publications up to date) is through attendance and participation at Regional Hydrographic Committee meetings.



- 2.6 The NAVAREA Coordinator's role is to engage and collaborate with national coordinators to ensure that standards and policy are properly implemented and adhered to. NAVAREA Coordinator contact with costal states is predominantly conducted by email with few opportunities for in person, direct engagement. NAVAREA Coordinator attendance at an RHC meeting is one way to increase coordination, cooperation and capacity. Another alternative is to establish a Maritime Safety Information Working Group (MSIWG), which can provide an avenue for coastal states to not only participate in their RHC, but participate in the MSIWG and the WWNWS's modernization to support S-100.
- 2.7 The following table details NAVAREA Coordinator attendance at RHC's. The highlighted rows indicate that there was no report or presentation from the NAVAREA Coordinator or it could not be determined from the meeting report or meeting agenda if no meeting report was available.
