1. Background

- 1.1 Capacity building is defined as the process by which the IHO assesses the status of current arrangements and assists States to achieve sustainable development and improvement in their ability to meet hydrographic, cartographic and maritime safety obligations.
- 1.2 The vision of IHO Capacity Building is to provide strategic guidance to ensure the optimum contribution to the safety of life at sea, to the protection of the environment, and to national economic development.
- 1.3 The purpose of the Maritime Safety Information (MSI) Capacity Building Course is to increase the availability of MSI in Regional Hydrographic Commission areas. The IHO designed the course primarily to train countries identified as a candidate for first phase capacity building. Additionally, the course could be for a country that needs MSI refresher training or, perhaps for the person who is newly appointed as the National Coordinator or NAVAREA Coordinator and needs to learn about the World-Wide Navigational Warning service (WWNWS) processes, methods, coordination and cooperation.
- 1.4 There are three expected outcomes for participants.
- 1.4.1 They will learn what resources they need to be informed of all events that could significantly affect the safety of navigation within a coastal region.
- 1.4.2 They will learn how to assess all information using expert knowledge for relevance to navigation in their coastal region.
- 1.4.3 They will learn how to draft navigational warnings in accordance with international standards and know which NAVAREA or National Coordinator to pass that information to for further promulgation.

2. Discussion

- 2.1. The WWNWS has facilitated and instructed the course in person since 2003. It has instructed a total of 27 courses for 453 students from 136 countries. At the end of each course the instructors provided students digital media with all course materials.
- 2.2. The establishment of the IHO's E-Learning Center provides several unique opportunities to improve and expand instruction, improve the availability of course material, and develop a supplemental E-Learning version of the course.

- 3.2. Create an advisory group to regularly evaluate an update course content
- 3.3. Develop a supplemental MSI Capacity Building E-Learning Course
