Wollongong is accessible by car, shuttle service or train.

**By Car From Sydney Airport.** An easy 1 hour and 20 minutes drive to Wollongong via the Prince's Motorway (M1 – formerly F6 Freeway) from the Sydney CBD.

# **Train.** Cityrail run commuter trains as follows:

Airport Line - between Sydney CBD (Central Station) to the Airport. Travel time is approximately 25 minutes.

South Coast Line – between Sydney CBD (Central Station) and Wollongong Station (adjacent the AHO). Travel time is approximately one hour.

It is possible to change directly from one line to the other at Wolli Creek (next station to Airport). For more information see <a href="https://www.sydneytrains.info">www.sydneytrains.info</a>. Travel on Cityrail commuter trains cannot be pre-booked.

#### Climate

Late March is into the early Australian autumn (fall). The climate in Wollongong is typically mild, with average temperatures range from maximums of 24° to 22°C and minimums of 17° to 14°C. Average monthly rainfall is between 127mm and 135mm.

#### **Electrical Power**

Mains voltage in Australia is 230V 50Hz. Travellers from most nations in Asia, Africa and Europe should have appliances that work on the same mains voltage as Australia - therefore you will not need a voltage converter. Notable exceptions to this are Japan, USA and Canada which uses 100/120V 50/60Hz. If your country does not use appliances within the 230V 50Hz mains voltage range, you will need to purchase a voltage converter. You will also need a power adapter (see below). The plugs in Australia have two live flat metal pins shaped in an inverted "V" and a third flat pin in the centre.
