Work Program

Task A.1

Through the work of the Schema and Editing Sub-Groups of S-130PT and the support of Expert Contributor (IIC), the S-130PT is able to provide a first edition of the S-130 Product Specification to HSSC for approval.

Task B.1

The development of an S-130 sample dataset (Task B.1) is pushed until after the HSSC-15 meeting (new end date 2023/2024). Consequently, testing (Task B.2) will only take place after conclusion of this development.

Task D.1

During the current reporting period, the S-130PT held three remote meetings, focusing mainly on relevant aspects for the development of the first edition of the S-130 Product Specification. Additionally, the Schema Sub-Group and Editing Sub-Group held separate meetings to work on their dedicated tasks, respectively in person and through VTC.

The fully detailed work program for the next reporting period is presented in Annex B.

Progress on HSSC Action Items

Problems Encountered

- A discussion has arisen within the S-130 Project Team regarding the producer of the authoritative S-130 dataset (cfr. <u>CL19/2021</u> and <u>A2/PRO 1.9</u>). While the S-130 Terms of Reference mention the creation of a dataset, some S-130PT Members believe that producing the official dataset should be left to the individual IHO Member States. The Project Team would therefore like to consult with the HSSC to resolve this matter.
- The S-130 Project Team is rather small in size, which leads to an unbalanced distribution of work.

Any Other Items of Note

Mr. Kayacan Ünalp (Türkiye) is no longer the Secretary of the S-130PT. This function is now being observed by Mr. Yong Baek from the IHO Secretariat.
