

PRINCIPAL ACTIVITIES AND ACHIEVEMENTS

Activities	Description
Development of work plan	PT have developed a comprehensive work plan to deliver assigned tasks
Interim OEM and Data server agreement	The existing OEM and Data Server agreements modified to include clause to limit duration and allow for termination.
Secured IC-ENC funding for legal support	UK lawyers Burgess Salmon have been appointed to support IHO drafting new S-63/S-100 OEM and Data Server agreements that are enforceable, contain reporting, rights of audit and termination clauses.
Application Process & Procedures	Drafted S-63 and S-100 OEM interim process for issuing M_IDs and M_Keys



PROBLEMS OR OUTSTANDING ISSUES

Problems/Issues	Description
S-63 M_ID &M_KEY delivery	Current handling of proprietary data is not cyber secure, proposal from 7Cs to improve process passed to S-100 WG for consideration
No OEM, Data Server appointment criteria	Currently there is no criteria for OEM or Data Server appointment. This is a huge risk and PT are working on providing an application process and appointment methodology for use by IHO.
Revocation of certification	It is necessary to have a revocation process in case Data Server private key is compromised or in the case of termination of agreement
ICE PT and IRCC S-100 funding PT collaboration required	Co-ordination required
Website information	Urgent need to publicly clarify purpose of the IHO security scheme, clearly set out timeframes for appointment and the detailed steps in the approval process

RECOMMENDATIONS

- Approval of PT outputs:
 - There are tight timeframes we need to work to so IHO can appoint S-100 OEMs and Data Servers.
 - The updated agreement is being drafted by legal experts so there would be no value in delaying implementation.
 - The process changes needed at the IHO will be minor and will support the new agreement by collecting better information about participants.
 - Recommend that IHO Technical Director be granted permission by HSSC to accept new IHO agreements when they have been drafted by Burgess Salmon.
