Progress on HSSC Action Items

Problems Encountered

- The representation of MultiPolygon geometry is critical for the development of S-130 (sample) datasets and the way this can be achieved within the S-100 framework is currently under discussion in the Project Team.
- The conversion of textual descriptions of locations into digital coordinates requires reliable sources that are supported by the Project Team and wider community.
- The S-130 Project Team is rather small in size, which leads to an unbalanced distribution of work.

Any Other Items of Note

Mrs. Britt Lonneville (Belgium) and Mr. Lingzhi Wu (China) were re-elected as Chair and Vice-Chair, respectively, of the S-130PT.
