Review of ICE PT 1 Decisions and Actions

[Action 1/03] ICE PT chair to circulate the work items that presented during the meeting to the PT members and the PT members to provide comments to chair prior to the next meeting.

[Decision 1/03] ICE PT recognized that defining the scope of the S-100 infrastructure center is of high priority as it significantly influences other work items of the PT. Consequently, a VTC meeting to discuss the scope of the PT and the Infrastructure Center will be scheduled before the next PT meeting.

[Decision 1/04] ICE PT agreed upon the timeline for the proposed PT work program during the meeting. Furthermore, to ensure adherence to this schedule, the PT decided to have additional meeting focusing on Scoping tasks of the infrastructure before the face-to-face meeting at the S-100 WG8 meeting in Singapore. Also, to meet the deadline of HSSC16 report submission, additional Face-to-face meeting was decided back to back with S-100 TSM9, Monaco, March 2024.

- ICE PT3: 18-19 Mar 2024 / Monaco

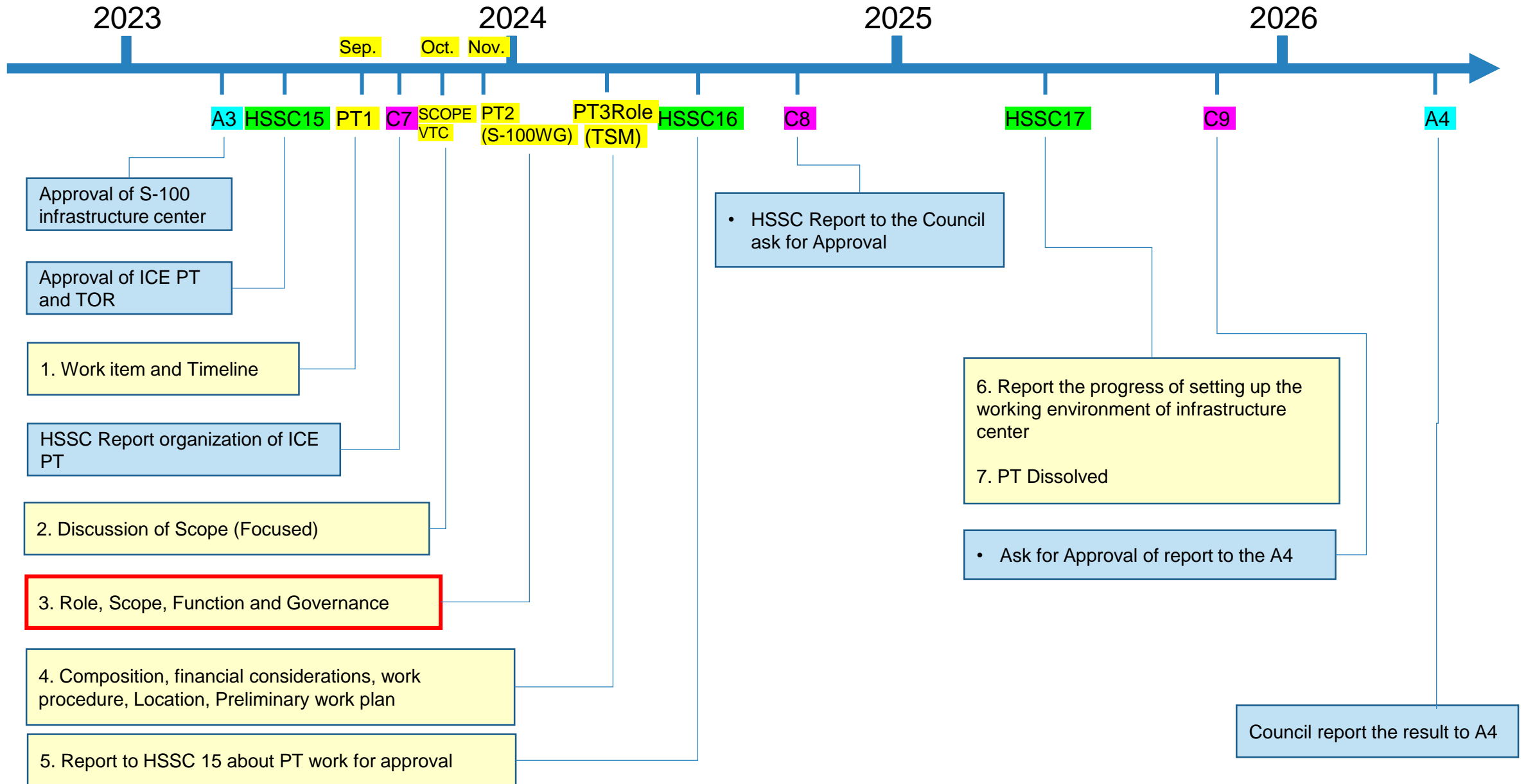

- Management of FC/PC/Schema
 - S-100 common schema
 - Support updating/creating FC/PC/Schema/IC within IHO (Basic PC if necessary)
 - Generic validation checks of PS components for the official use
- S-164 TDS
 - Support updating the S-164 TDS (e.g. screen shots)
