S-101 2.0.0 Delivery Update

Dear S-101 Project Team Members,

I wanted to provide a short update on our progress since the PT 13 meeting to prepare a final draft version of S-101 2.0.0 for approval via the various IHO bodies and the IHO member states.

1. PT 13 Meeting

Thanks to all who were able to attend and contribute to this meeting. Although we had a fairly packed agenda, I was pleased that we were able to reach resolutions on the items needed to progress with a final 2.0.0 draft. I was also pleased that we had some new attendees and I really hope that our new members continue to participate in Project Team activities.

2. <u>S-101 2.0.0 Delivery</u>

Since the PT13 meeting the focus has been on the preparation of edition 1.4.0 of S-101, as we agreed this version would go for S-100WG approval. Following the provision of a draft DCEG, Bluemap prepared a revised Feature Catalogue. Following review including through the new Data Quality Working Group "checking tool" some further consistency changes were identified. These have now resulted in version 1.4.1 being prepared for the Main document, the DCEG and the Feature Catalogue. In addition to addressing inconsistencies between the DCEG and Feature Catalogue the changes made reflect work on Text Placement as agreed at S-101PT13 and further amended to address inconsistencies as discussed at a dedicated Text Placement meeting between key stakeholders held on 15th July.

Further to discussion at PT13, Annex A of this letter provides the updated S-101 Edition 2.0.0 delivery schedule that we are following.

As a result of this progress, yesterday I submitted the documents to the S-100WG Chair for approval via a S-100WG Circular Letter. These documents can also be download from the S-101 entry in IHO GI Registry/Test Bed/Product Specifications. I encourage all PT members to review these items and further encourage their S-100WG representative to respond promptly. For Project Team members, the "master" MS Word Edition 1.4.1 redline and clean versions of the S-101 Main Document and DCEG, containing the cumulative list of changes from Edition 1.2.0, can be downloaded from the Documents (Main and DCEG) folder in the S-101 Documentation and FC GitHub repository.

I would also like to once again recognize the significant support to this work from our expert contributors Bluemap, NIWC and Teledyne CARIS. As ever Jeff Wootton has also undertaken significant hard work in applying changes from the PT meeting to tight deadlines.

Wishing everyone well and look forward to seeing you at future meetings or online for our next PT meeting.
