The phrase "Structure implementations" from the sentence "ISO/IEC 8211:1994, Specification for a data descriptive file for information interchange Structure implementations." should be omitted.

Change Proposal Justification

The title of ISO/IEC 8211:1994 is "Specification for a data descriptive file for information interchange", while "Structure implementations" is the title of section 10a-4. The mention of "Structure implementations" in the sentence appears to be a typographical error.

Change Proposal (10a-4.4)

"The body of the table specifies the subfield names and labels as well as the ISO/IEC 8211." should be changed to "The body of the table specifies the subfield names and labels as well as the ISO/IEC 8211 format." Add "format" at the end of sentence.

Change Proposal Justification

The terms "subfield name," "label," and "ISO/IEC 8211 format" correspond to the column name "subfield name, label, format" in the provided example. The inclusion of "format" enhances the clarity of the correspondence.
