PROGRESS SO FAR

- Since S-101PT 5 (Sept 2020) the Project Team has made significant progress in developing S-101 through 5 PT meetings and numerous sub-group meetings
- A significant challenge has been the development of the S-101 Portrayal Catalogue
- In April 2023 edition 1.1.0 of S-101 was published and this was the first version to include a Portrayal Catalogue and draft Validation Checks
- We have received some feedback but due to the lack of testbed systems testing activity remains limited (S-98 and S-164 are key dependencies)

CURRENT STATUS

- In support of the S-100 Roadmap HSSC 15 set out timeframes for approval of edition 2.0.0 of S-101 by HSSC by correspondence in summer 2024
- At S-101PT 10 a plan was agreed to deliver edition 1.2.0 as an incremental step towards 2.0.0 and hold 2 meetings in 2024 to maintain momentum
- A number of issues remain to be resolved for 2.0.0 as detailed in the various reports provided to this meeting
- Using IHO contract support good progress has been made on S-101 Test Datasets and these have supported progress on S-164



WAY AHEAD - STEP 1 DELIVER 1.2.0

- 1.1 Conduct a final 1.2.0 review cycle of the DPS and DCEG IHO Sec All PT Members by 27th October 2023
- 1.2 Resolve comments from review and prepare final documents including Feature Catalogue 1.2.0 IHO Sec by 2nd Nov 2023 (DQWG consistency review follows in parallel)
- 1.3 Submit to S-100WG8 for endorsement of completed 1.2.0 components Chair 13th Nov 2023
- 1.4 Prepare 1.2.0 Portrayal Catalogue, Validation Checks and Test Datasets Sub-Group Leads by 22nd Dec 2023
- 1.5 Final S-100WG Approval of 1.2.0 by letter Chair Jan 2024



WAY AHEAD - STEP 2 DELIVER 2.0.0

- 2.1 PT12 meeting Feb 2024 (13th-15th Remote) to review proposals for 2.0.0 and action further feedback from 1.1.0 testing
- 2.2 Sub-groups to progress changes and prepare final drafts (Mar-Apr)
- 2.3 Chair to report progress to HSSC 16 27th May 2024
- 2.4 PT13 meeting to conduct final adjudication of 2.0.0 17th-20th June 2024 (In Person) Sweden (substantive papers to be submitted 4 weeks in advance 17th May)
- 2.5 Prepare final content and DQWG review (Jun-Jul) DPS, DCEG, Validation Checks, FC, PC TDS



S-101 2.0.0 TIMELINE



- Capacity we remain reliant on limited resources, but the number of changes are now stabilising, SG leads are best placed to comment
- Dependencies we remain dependent on S-98 and S-164 this impacts testbeds and we need to be realistic that given the timeframe testing will be limited
- Outstanding Issues there are a number of items that need to be resolved before edition 2.0.0 can be finalised although some are making progress
