#### CALL FOR THE APPROVAL OF THE IHO RESOLUTION – THE EX ABYSSIS AD ALTA – IHO AWARD FOR HYDROGRAPHIC EXCELLENCE

Dear Hydrographer,

1. In reference A, the 7<sup>th</sup> IHO Council endorsed the proposal from HSSC and IRCC for the introduction of an annual Champion of Hydrography Award. The proposed award aims to supplement the *Prince Albert the 1st Medal for Hydrography* granted by the Government of the Principality of Monaco by offering an annual opportunity for the IHO to recognize mid-career achievements and expanded award eligibility in hydrography.

2. The proposed award was designed by the HSSC and IRCC Chairs with support from the IHO Secretariat. The Latin phrase *Ex Abyssis ad Alta* was chosen as the name of the award in honour of Prince Albert I<sup>st</sup> of Monaco who used it as his personal motto. With this reference, the Award pays tribute to the instrumental role of the Grimaldi family and the Principality of Monaco in the establishment and continuation of the international collaboration in hydrography.

3. The final proposed version of the IHO Resolution on the Proposed *Ex Abyssis ad Alta* – *IHO Award for Hydrographic Excellence* is provided in Annex A.

4. Member States are requested to note the general endorsement of the proposal by Council 7 and are invited – in accordance with reference B – to consider the adoption of this new IHO Resolution on the *Ex Abyssis ad Alta – IHO Award for Hydrographic Excellence* by providing their reply at their earliest convenience and **no later than 1 April 2024** by email (<u>cl-lc@iho.int</u> when using the Voting Form in Annex B), but preferably using the IHO Online Form System by accessing the following link:

#### Introduction

1. The *Ex Abyssis ad Alta* - *IHO Award for Hydrographic Excellence* was introduced in 2024 following a decision at the IHO Council 7. The aim of the Award is to recognise a champion of hydrography across the global community and IHO Secretariat excluding the Secretary-General and the Directors. The Latin phrase *Ex Abyssis ad Alta* – was the personal motto of Prince Albert I of Monaco. In referencing the motto, the Award pays tribute to the instrumental role of the Grimaldi family and the Principality of Monaco in the establishment and continuation of the international collaboration in hydrography.

#### Nominations, eligibility and achievement criteria for the Award

- 2. Each IHO Member State, through their National Hydrographer, may present one nomination for the Award by the first day of May every year, using the form shown in the Annex to this Resolution.
- 3. Employees of governments, intergovernmental organizations, private industry, and of the IHO Secretariat (excluding the Secretary-General, IHO Directors, current Chairs of IHO Committees, and current Chair of IHO Council) are eligible to be nominated. The award is designed for individuals, however groups, companies, organizations, shared, or other non-individual awards will be considered.
- 4. Though not absolute, nominations should be oriented toward mid-career individuals. Nominations for career level accomplishments or lifetime achievements should be reserved for the *Prince Albert 1<sup>st</sup> Medal for Hydrography*.
- Achievement criteria are specific examples of innovation, original work, exceptional achievement or exceptional devotion which may represent technical, systematic, administrative, scientific, coordination, diplomatic, or other field of focus in support of the IHO and its Member States.

#### Award Board and selection process

6. The composition of the *Ex Abyssis ad Alta* Award Board includes the Chairs of IHO Council and IHO Committees along with the IHO Directors. The Board will select one recipient of the Award for proposal to the Secretary-General for approval. The Board may also conclude that there is no suitable candidate to recommend for the Award. Should the Award Committee fail to agree on a single candidate, the IHO Secretary-General will decide based on the short list of candidates proposed by the Board.

## Award Timeline and Description

- 7. The Award recipient will be announced on June 21, World Hydrography Day, each year.
- 8. The recipient will receive a lapel pin, have their name engraved on the IHO Wall of Hydrographic Excellence (IHO Secretariat), and have an article describing their accomplishment published through IHO public relations (website, social media, International Hydrographic Review, or other means of distribution). The recipient will also be allowed to use the Award logo on business cards, CVs, etc.
- 9. The Award will be delivered to the recipient, normally by the IHO Secretary-General or by one of the two Directors in case the Secretary-General is not available, at an occasion that is agreed between the IHO Secretariat, the nominating office, and the Award recipient, preferably during an IHO related meeting or event, including but not limited to meetings of Council, IHO Committees, Regional Hydrographic Committees and Working Groups.

### **Financial impact**

10. Expenses for the award, lapel pin, engraving, and media will be covered by the IHO operational budget. Any associated travel or additional expenses for the Award recipient shall be covered by their Hydrographic Office, organization, company, or sponsoring entity.

#### General Data Protection

11. Member States are informed that their country names will be listed in the report for those who made the nominations, but the nominations themselves and the list of nominees will be kept confidential.
