Madame la Directrice, Monsieur le Directeur,

1. Conformément à la référence A, la lettre circulaire de la référence B proposait l'adoption des éditions 2.0.0 des publications S-5B et S-5A de l'OHI intitulées « Normes de compétence pour les hydrographes », ainsi que des publications S-8B et S-8A intitulées « Normes de compétence pour les spécialistes en cartographie marine et les analystes géospatiaux marins ».

2. Le Secrétariat de l'OHI remercie les quarante-cinq Etats membres qui ont répondu à la référence B : Algérie, Argentine, Australie, Bangladesh, Belgique, Brésil, Bulgarie, Canada, Chili, Colombie, Chypre, Danemark, Fidji, France, Allemagne, Grèce, Indonésie, Iran (République islamique d'), Irlande, Italie, Japon, Liban, Malaisie, Maurice, Mexique, Maroc, Pays-Bas, Nouvelle-Zélande, Nigéria, Norvège, Oman, Pérou, Philippines, Pologne, Portugal, République de Corée, Singapour, Slovénie, Espagne, Sri Lanka, Suriname, Tunisie, Ukraine, Royaume-Uni de Grande-Bretagne et d'Irlande du Nord et Uruguay.

3. Les quarante-cinq Etats membres ont approuvé l'adoption de la proposition d'édition 2.0.0 de la norme S-8B ; quarante-quatre Etats membres ont approuvé l'adoption de la proposition d'édition 2.0.0 de la norme S-8A ; et quarante-trois Etats membres ont approuvé l'adoption des propositions d'édition 2.0.0 des normes S-5A et S-5B. Six Etats membres ont formulé des commentaires en plus de leur vote. L'ensemble des commentaires reçus sont contenus dans l'annexe A de la présente lettre circulaire, accompagnés des réponses du président de l'IBSC et du Secrétariat de l'OHI.

4. Au moment de la publication de la référence B, l'OHI comptait 104 Etats membres, dont deux étaient suspendus. Conformément aux dispositions de la Convention relative à l'OHI telle que modifiée, le nombre minimum de voix favorables requis est de 34. En conséquence, les éditions proposées susmentionnées ont été adoptées et sont désormais disponibles (en anglais uniquement) sur le site web de l'OHI > Publications > [Standards and Specifications](#).

5. Le Secrétariat de l'OHI félicite les membres de l'IBSC pour l'aboutissement réussi de leurs travaux et pour l'adoption des nouvelles éditions des publications de l'OHI S-5A, S-5B, S-8A et S-8B.

General comment:

The overall revision of the second edition of the S8 Standard is welcomed and supported. However, it is noted that the revised edition introduces the S100 framework, while the associated training materials also reference S102. In this regard, it is recommended that the corresponding Learning Outcomes be incorporated to ensure closer alignment between the training content and the competencies expected of learners.

Furthermore, considering the scope and level of the course, it would be beneficial to provide participants with introductory exposure to other products within the S100 framework, including S104 and S111. This would further strengthen the alignment of the educational objectives with the evolving operational environment of the S100 framework and better prepare learners for its broader implementation.

Comments by the IBSC Chair and IHO Secretariat:

The IBSC Chair and IHO Secretariat thank Iran (Islamic Republic of) for its vote and comment. However, the consultation process initiated through IHO Circular Letter 48/2025 was conducted from 19 December 2025 to 3 March 2026. It is therefore too late to incorporate any changes, other than minor typographical corrections, into the editions currently submitted for approval.

Nevertheless, it is important to emphasize that the Standards establish the minimum requirements for the respective levels of competence. Institutions are not only able, but are also encouraged, to include additional content and enhance the corresponding learning outcomes in accordance with their specific programmes and educational needs. The IBSC will take due note of the comments for consideration in a future revision of the S-8A Standard.

Comments by the IBSC Chair and IHO Secretariat:

The IBSC Chair and the IHO Secretariat express their appreciation to Chile for its support and for the corrections provided. With regard to the comments concerning taxonomic levels, it is noted that the consultation process initiated through IHO Circular Letter 48/2025 was conducted from 19 December 2025 to 3 March 2026. Consequently, it is no longer possible to incorporate substantive changes, other than minor editorial corrections, into the editions currently submitted for approval. The IBSC will duly take note of these comments and give them due consideration in a future revision of the S-5A Standard.

General comment:

NL thanks IBSC for their hard work on S-5A/B but considers that the current versions cannot be approved without reasonable doubt. Indeed, all stakeholders were invited to comment (IHO CL48/2025), which both certified institutions in NL did. Their contributions were well-formulated and in-depth. IBSC included some of their contributions, but not all and substantial concerns remain. The institutions did not receive a response, explaining why some suggestions were not applied. IHO Secretariat commented that the lack of response was likely due to the high work load of the Board. In order for an updated standard to be authoritative, a feedback step is absolutely necessary. As a matter of principle, the PDCA circle has to be closed for all new editions of standards: a stakeholder check without a corresponding feedback action has significant impact on the acceptance of the result by those stakeholders. Moreover, the lack of clarity prevents the HO from formulating an opinion on the severity of their concerns. Therefore, NL cannot vote in favour of the new standard.

Comments by the IBSC Chair and IHO Secretariat:

The IBSC greatly appreciates the valuable comments received from MIWB (S-5 Cat. A), Skilltrade (S-5 Cat. B), and all other institutions during the consultation process. While the Board had intended to provide individual feedback on the comments received, the high number of contributions, together with the tight timeframe for finalizing the revised Standards and the unprecedented number of programme submissions for recognition at IBSC49, unfortunately did not allow sufficient time for the Board to prepare individual responses during the annual meeting. After the meeting the Board also had to prioritize the fourteen intersessional reviews offered and the urgent revision of the Guidelines to align them with the approved Standards to allow institutions to begin preparing their submissions under the new edition of the Standards.

The IBSC fully regrets this situation and recognizes both the importance of providing detailed feedback and the disappointment that the absence of individual responses may have caused. The Board has already started preparing the requested feedback, which is expected to be available shortly after the urgent revision of the Guidelines is completed.
